FOREWORD

As editor I have tried to show that this series of books is far from being the thoughts and conclusions of just one person. We take human government back to the beginning of civilization and also show that over at least 500 years, elitists have understood their manipulative powers so well as to be free of concern about secrecy. So long as they held the reins of communication that was all the control needed.

When there is so much information to choose from there has to be a lot of leftovers. We can't use it all and many people now cannot concentrate to read more than a few pages at a time, so books have been kept within limits. Here, in seven views, we chose from important leftovers.

Books 4 and 5 are for those who have read the first three books in this series. Others risk failure of understanding, or worse, of missing information needed for honest judgment! We here bring in a selection of literature to conclude and reveal the full depth of Globalist atrocities. This is not about freakish fanatics gaining temporary control.

Those who have read pieces of this project in progress will see the benefits of having information in related order. Revisions have produced a literature whose overall value as a vehicle for understanding our world situation is much higher than the sum of its parts.

In whole these books include behaviour and health of mind and body. One of our big health risks today is cancer; that this is a nutritional disease, as is scurvy, was exposed by G. Edward Griffin in "World

Without Cancer". Had our culture been democratic, medical research would then have turned to nutrition and today's inefficient medical system would now be of well-run special units dealing mainly with accidents.

However, as we have seen, the establishment was working to cut population growth and without official support and publicity a book is not enough to alert the sedated majority. Now more aware of underlying problems, let's look deeper.

Books are also kept short to spare sensibilities; when we close our eyes to truth; the evidence becomes irrelevant! The mass of evidence backing exposure is far beyond our needs. For more detail see literature on site or mentioned in these selections.

It is not uncommon, when talking to concerned people, to hear them say; "I just cannot deal with that kind of thing it gives me nightmares; it's too awful to think about!" If that's your reaction, think about this: If we close our eyes to what is going on in our world we cannot do anything to stop it, and what we close our eyes to today, will advance to greater horrors that, in the end, will not spare us.

So, if truth is now too awful to face, think, how awful will it be when catastrophe, in one form or another, reaches your doorstep! When you have closed your eyes to what is happening in another country; another street or neighbourhood, who will you appeal to when your turn comes? Be assured, when atrocity blooms in other parts of a United Nations culture it is also growing in our area.

Now largely forgotten, or hidden from public scrutiny, is the United Nations instigated atrocities in Katanga (Congo) I refer you to the Congo because both Katanga and its capital city Elizabethville, were, by name change, sent down the memory hole.

Katanga regained its old name in 1997 but Elizabethville, because of shame of events there, remained deleted.

Griffin also wrote other revealing literature but was unable to expose the true depth of the problem as exposed here. Perhaps that was because his time was too early for full exposure or perhaps because he did not have time to complete the evidence. Whatever the cause our first article here is in partial review of another of his well-researched works.

Section 1.

The U.N.TRAP: A Shame of Nations

A short review of G. Edward Griffin's 1964 book "The Fearful Master" with references to other works on the same subject and pointers to other knowledge of our world.

It is assumed the reader has read earlier books in this series otherwise the evidence of atrocity, little over forty years old, will be hard to comprehend. I think the campaign we cover here rates as among the most inhuman of the many obnoxious military campaigns of the last hundred years.

I place it ahead of atrocities in Cambodia, various African States and the Balkans! Acts of military mass murder, carried out on orders of leaders said to be acting on

behalf of our most advanced nations, must rate more highly on a scale of heinous than even worse actions carried out by primitive ideological fanatics. This episode also helps us understand our world situation in relation to imposed ideology.

Don't think that atrocity reported here is unique to our times or does not continue. Its importance is that it shows how shamefully we are now failing to advance as humans. We can only imagine what happens when ignorant tribes, hardly out of cannibalism, are given guns and drugs to ravage defenceless communities and villages of traditional tribal enemies.

Our socialist/humanist culture may tell us that these people are our equal in their own civilization – that these only express themselves differently – but humanist indoctrination is not logical judgment.

That is why this UN action is so contemptible.

As an introduction to "The Fearful Master" book let us have a few words from its own foreword:

Quote: "Wherever possible, quotations used in this book are from original sources. These sources have been thoroughly footnoted in hopes that the skeptic will check them out. ...

"Most of the documentation is taken from those people or sources friendly to the United Nations." ...

"Likewise, the forty-six civilian doctors of Elisabethville, who provided some of the most horrifying eyewitness accounts of United Nations atrocities, have declared: . . . we believe in the UNO . . . we

proclaim that such an organization is necessary for maintaining peace in the world and fair betterment of undeveloped nations."

Yes most of the human world is so completely indoctrinated or fooled by the use of simple strategies of PR, that even those who witness atrocities ignore evidence of eye and logic of mind. Reality, as we so often see, is just too shaming to face.

But when children, who should be freely exploring the real world and learning human values are watching pretend people behaving unnaturally in pretend lives – when ideologues use entertainments to present an artificial life ‘dialectic’ to wire innocent child minds to fake beliefs and attitudes – when children are herded into kindergartens to learn to submerge their natural individuality within a herd consensus of primitive attitudes and peer group fixations – when unhealthy diet is massively promoted by mass media with government approval – then we must expect to live with increasing violence, unhealthy bodies and primate attitudes!

Let’s look at preliminary evidence so that we may better understand what happened in ‘Elizabethville’ and what is happening in our world today. First the four intermediate goals of communism as laid down by Stalin as preliminary to the ultimate goal of global conquest: quote from “The Fearful Master”: Underlining added.

"Confuse, disorganize, and destroy the forces of capitalism around the world.

[Capitalism is in control; Stalin loved its Communist twin. But Capitalism

promotes communism; Hegelian Dialectic completes the confusion!]

"Bring all nations together into a single world system of economy.

[Now, in effect, completed!]

*"Force the advanced countries to pour prolonged financial aid into the undeveloped countries. ** [To undermine existing cultures and give false face to communism. Setting in place the artificial ‘opposites’ dialectic has destroyed all natural culture at huge cost of misery.]

*"Divide the world into regional groups as a transitional stage to total world government. Populations will more readily abandon their national loyalties to a vague regional loyalty than they will to a world authority. Later, the regionals [such as the present NATO, SEATO, and the organization of American States] *can be brought all the way into a single world dictatorship of the proletariat.****

* [The USSR itself received huge aid until the "NWO Casino" found that bogeyman was un-needed then (having served its purpose) by its own impractical structure it was allowed to self-destruct – the world economic system was free to remove the props and give communism public face of socialism.]

** [This is to be achieved by United Nations use of Hegelian dialectic to overwhelm nations gradually in association with the present ‘mind manipulating’ ‘dumbing down’ program.

Today we see the mighty US crumbling in unpopular conflict. Our Capitalist re-education is pursued later in this book.]

Humanism always needed a United Nations to give it a 'peace' image but this 'peace' really meant the peace that would come after all opposition had been deleted by death or indoctrination. The quirk in the above (*dictatorship of the proletariat*) like 'dictatorship of democracy', is a self-contradiction. Self-dictatorship is by dogma. Democracy represents the people – a living, freely advancing organism not a stagnant ideology.

More from, "The Fearful Master": Emphasis added: Quote: *"During the Korean War, a New York grand jury accidentally stumbled across evidence of Communist penetration into the American staff of the United Nations. One piece of evidence led to another and so alarmed the grand jury that it proceeded to conduct a full-scale inquiry into the matter."*

"The publicity attracted a great deal of attention and prompted the Senate Committee on the judiciary to initiate a parallel investigation of its own. Shortly after the investigation began, some two hundred Americans employed by the UN resigned, apparently to avoid testifying. Those that did testify, however, provided more than ample evidence for the grand jury to issue the following presentment:

"This jury must, as a duty to the people of the United States, advise the court that startling evidence has disclosed infiltration into the UN of an overwhelmingly large group of disloyal U.S. citizens, many of whom are closely associated with the international Communist movement."

This group numbers scores of individuals, most of whom have long records of federal employment, and have at the same time been connected with persons and

organizations subversive of this country. Their positions at the time we subpoenaed them were ones of trust and responsibility in the UN Secretariat and its specialized agencies."

"The Senate investigations produced exactly the same conclusions. Senator Eastland, chairman of the committee, made the following statement at the conclusion of the hearings: 'I am appalled at the extensive evidence indicating that there is today in the UN among the American employees there, the greatest concentration of Communists that this committee has ever encountered."

'Those American officials who have been called represent a substantial percentage of the people who are representing us in the UN. ...'

'These people occupy high positions. They have very high salaries and almost all these people have, in the past, been employees in the US government in high and sensitive positions. I believe that the evidence shows that the security officers of our government knew, or at least had reason to know, that these people have been Communists for many years.

'In fact some of these people have been the subject of charges before Congress before and during their employment with the UN.

It is more than strange that such a condition existed in the government of the U.S., and it is certainly more than strange that these people should be transferred to the UN and charged to the American quota.'

"It takes the better part of a day to read through the transcript of the hearings that led up to that conclusion, but for those

who have the time, it is well worth the effort"

The exposure above occurred because citizens of the USA saw communism and capitalism as opposites.

Communism/Fascism, calling itself Capitalism, is today the dominant way of both the US of A and our world. The branches were cut off communism but the roots remained. Its bible is humanism and to stand against it, for truth, is now considered by most as treason or at very least out of step, and politically incorrect.

We do not call ourselves socialist but accept socialist political decisions.

If you think what is happening could not happen in a true democracy, you are right.

This takeover, along with holding the U.S. Constitution in suspension for many years, is treason but, not having taken advantage of what we had, how can we feel badly about its loss.

Giving control of the economy to an alien entity happens when people in high places are able to 'shoe-horn' quislings into commanding positions. We will see in the AIDS article how easily this is done.

Globalists have demonstrated the power of gradualism to blacken the names of opponents who would expose these matters.

We have seen how Globalists set policies of our governments! Only when we understand our fragile 'constitutional democracies', can we make sense of government decisions and understand communist style atrocities being instigated by the U.N. Quote:

"... measures that have been presented to the American people as ways of fighting communism. Foreign aid is probably the most obvious example. President after President has told us that we have to send billions to various Communist and pro-Communist in order to win them away from Soviet domination.

We have shipped them military equipment, trained their officers in our military schools, sent them machine tools, built whole factories and power dams for them, and sold them subsidized wheat. Our politicians have shrewdly borrowed the required money from our children and grandchildren.

"... A glance at a few issues of "People's World" or the "Worker" or other Communist periodicals will cause even the skeptic to realize that our foreign aid is very near and dear to the hearts of Communists everywhere. The only criticism one finds of our foreign aid program in the Communist press is that it isn't as large and doesn't grow as fast as Communists want....

[Leaders of today's terrorists were trained by our military and are then, by economic and military force, pushed to use terrorist tactics against us!]

"By 1945 the blueprint was being drafted into its final form. Delegates from countries all over the world were preparing to participate in a conference at San Francisco which was to mark the creation of something called the United Nations.

"Earl Browder, well known past leader of the United States Communist Party, in his book "Victory and after", stated: "The American Communists worked

energetically and tirelessly to lay the foundations for the United Nations, which we were sure would come into existence.” The April 1945 issue of the Communist periodical “Political Affairs” explained to its readers the importance of getting the capitalist countries committed to this international body.”

We had to be duped to believe in the U.N. otherwise we would recognise the Trojan Horse. Even communist sympathizers should be disturbed to find their ‘democratic’ governments hosting this treacherous deceit. This has consolidated since it was exposed, so it seems we are now in a situation referred to years ago; quote:

“Treason never prospers; what’s the reason? For when it prospers none dare call it treason.” Sir John Fortescue

It was important to have the ‘common’ classes believe the UN was planned for peace. Many of the wealthy, socialist leaning, do not feel threatened. They have power, they feel comfortable to cheer for the underdog – they feel they present themselves as being good socialist citizens and will be accepted. They should look more honestly; what they support is not what it seems.

Katanga was one of Globalism’s few exposed mis-takes; a mistake resulting from the arrogant accumulation of communist ideologues (used to set up the UN) wanting, in the delirious joy of success, to throw their weight around. U.N. “peace-keeping forces” now take no part in atrocities, they just look on and keep their own peace.

Communist zeal no longer worries Globalists! They have proved they

control and can easily hoodwink the sedated masses. The UN is only there as part of the charade to distract world attention from the true masters and seduce peoples into the belief that their nation is part of a new world peace movement – a ‘political’ promise. But not all are fooled.

Quote from a newspaper article by Shirley Hazzard author of “Countenance of Truth: The United Nations and the Waldheim Case”: *“The United Nations was established as a place of standards – an institution in which candour and harmony between citizens and nations would be encouraged. Instead it is the most secretive institution I have ever had to deal with, and the most fearful.”*

If I no longer have confidence, as I once did, that events will propel it irresistibly into the light of day, allowing new forms of international mediation to take place, that is because circumstances no longer seem conducive of such a rational and generous resolution of the present impasse – and because the UN itself has clung too long to its particular darkness.” End quote.

“a place of standards” and international consensus. Yes that is the image the United Nations presents to a world desperately wanting to believe it.

This was accepted by the trusting masses as meaning the highest human standards, not standards set by those who teach “no truth, no atrocity, no values”; the standards of brute force that will allow the beast to be carried on the backs of a slave class. The UN does not say a lot about truth and justice nor, by its actions, show concern for these.

Under pretext of 'peace-keeping' the UN sent forces into Katanga and, in the Communist way, committed atrocities. A Chicago News correspondent report from Elisabethville on the 12th December 1961; Quote from "666" by Don Stanton. *"The United Nations Jets next turned their attention to the center of the city.*

Screaming in at treetop level while excited soldiers and white civilians popped away at them with anything from 22 pistols to submachine guns, they blasted the Post Office and Radio Station, severing Katanga's communications with the outside world."

At the height of the U. N. attack on Elisabethville, Mr. George Olivet, the Swiss International Red Cross representative there, cabled an appeal to his Geneva office to persuade the United Nations to stop firing on Red cross vehicles. A few days later he disappeared while on a mercy mission to U. N. headquarters. It was not until eleven days afterwards that his wrecked ambulance was found. It had been hit with bazooka rockets and machine-gunned by U. N. troops.

From "The Great Betrayal" by Earnest N. Miller. *"Forty-six civilian doctors of Elisabethville unanimously issued a joint report on the United Nations actions against Katanga which included the following account of the December 12th 1961, bombing of the Shinkolobwe hospital:*

"The Shinkolobwe is visibly marked with an enormous red-cross on the roof of the administrative pavilion . . . At about 8 a.m. . . . two airplanes flew over the hospital twice at very low altitude; at

about 9:30 a.m. the airplanes started machine gunning . . . the market square, and then the school and the hospital in which there were about 300 patients and their families. . . .

"The administrative building, the left wing of the four pavilions and the household buildings . . . were bombed and show hundreds of points of impact made by the machine-gun bullets. In the maternity, roofs, ceilings, walls, beds, tables and chairs, were riddled with bullets; a bomb exploded in another pavilion . . .

"The blood from the wounded makes the buildings look like a battlefield . . . Out of the 300 patients 240 fled into the bush, refusing to be evacuated to any other hospital, for they say . . . "the UNO prefers to aim at the hospitals and we would henceforth no longer feel safe there."

Do we wonder why hospital, ambulance, school and Post Office buildings would be preferred targets?

Well the hospital doctors were shouting, to the world, for help through the Post Office. Technicians who did not leave earlier, including these 46 angry men who made international protest, were mainly European Aid workers. If European institutions commit atrocities, the less European witnesses the easier the cover-up.

That aim may not appear to have succeeded but we also see the Globalist mind-web easily fools a population that does not want to see.]

"Professor Ernest den Haag made a personal visit to the Congo to witness first

hand the events and conditions there. In commenting on the United Nations statement that the only civilians wounded in Katanga were combatants in the resistance, he said:

"It is hard to speak, as I did, with a mother whose husband was killed at home in her presence with bayonets by UN soldiers. " She was in the hospital to help take care of her six-year old child, severely wounded by United Nations bayonets. A child's bayonet wounds are hardly due to being suspected of being a mercenary or a combatant.

...

"The doctors of Elisabethville reported the "triple and particularly heinous assassination of three elderly people" on December 16th, 1961, as follows:

"The . . . "boy" of Mr. Derriks, Mr. Andre Kapenga, a witness, relates that nothing special occurred until 1:45 p.m. At this moment, the old cook, Mr. Jean Fimbo, had just brought coffee into the drawing room, and Mr. Guillaume Derriks (60-year old Belgian) and his elderly mother (aged 87) who lives with him, are about to drink it.

"At that moment, an armored car of the UNO takes up position on the path . . . and is machine-gunning the other side of the valley . . . When the firing has ceased, [United Nations] mercenaries enter the garden . . . and machine-gun the two cars parked in the garage.

"The "boy" Andre Kapenga, is panic stricken; he locks himself in the food store next to the kitchen. The [soldiers] climb the stairs leading from the garage to the kitchen and with a burst of machine-gun fire shoot Mr. Jean Fimbo, who has sought refuge under the sink . . . enter the

drawing -room where Mr. Derriks cries out in English: "Not me," is shot down ... and finished off by a burst that blows off half his face and skull.

"A few seconds later a third burst hits Mrs. Derriks in the right breast . . .

"Assistant Secretary of State and African Affairs G. Mennen Williams, speaking in Detroit, accused the Katangese government of fabricating what he called "horrendous tales of indiscriminate mayhem by United Nations troops during their December attack on Katanga. Millions of Americans read Williams' assurances in their newspapers and were relieved.

Practically no one has read Smith Hempstone's reply:

"Unquestionably, the Katanga Information Service had played up United Nations atrocities, real or imagined, for all they were worth. Williams might have been in a better position to judge, however, had he spent some time in Elisabethville's *Leo Deux* while UN mortar shells rained down during those last days before Christmas. Every newsman there had seen civilians shelled with his own eyes.

"Each of us had seen Red Cross vehicles destroyed by United Nations fire. Or were all of us lying? Georges Olivet, the Swedish Red Cross representative, lay in his shallow grave in testimony that we were not.

"Sanche de Garamont of the New York Herald Tribune might well have sent Williams a few pieces of the shrapnel picked from his body after United Nations troops shot up the civilian car in which he was leaving Elisabethville."

You may be asking: how could these things have happened and memories of it disappear so quickly from the forefront of common awareness in a modern world? How can the UN continue to get massive public support?

However, having read books 1 & 2 you know that, in the main, people do not want to know disturbing things. We, naturally passive, like sheep are misled by devious dialectic. We are indoctrinated to believe and trust blind leaders; how many will die in misery before eyes open?

Shame of Nations & Shame of People.

Yes the way of elitist power is to mould children in common servitude 'to slavery of ignorance or destruction'. When you believe "*There is no God, and there is no soul.*" no moral right or wrong; that your own desire is the only measure – then you do not see that those who promote these ideas must know, or think, that life has much more to offer! If not, even in their own twisted minds they would find no incentive for their atrocities.

What is wrong with binding humanity to a shape some un-reasoning fanatic thinks is ideal?

Well it blocks off natural development and ends with natural destruction! Even in our present low state and facing disaster, we are still on the verge of our greatest advance; where now could we be had our convictions not become dogma stagnant – were we not corrupt in behaviour, ideals and energies?

It is amazing that people are horrified by thought of cloning bodies (slow & difficult) but totally ignore mass mind-cloning of their children – a cloning, not

to make all the same but rather to reduce all to primate mental responses – to destroy the independence and the understanding that would allow choices and effective defense of individual interests.

We send our children to school but complain of genetically modified food though most of our children will be unable to understand what they eat.

The UN is a 'Shame of Nations' but the good-natured passivity of humanity that allowed it may, if we now awaken, be a cause for satisfaction. Had it not been for our passive nature the cruel greedy would never have exposed themselves.

Section 2.

Education to Collectivist Religion

Evil means anti-life! Evil thought to create an escape-proof mind-cage but, being evil, thought wrong. If we know of evil we avoid it. We now add to evidence and consequences of evil to help those who have human caring!

In 1918, shortly after the Bolshevik Revolution in Russia, a congress of Party education workers stated:

"We must create out of the younger generation a generation of Communists. We must turn children,[they] can be shaped like wax, into real, good Communists...."

"We must remove the children from the crude influence of their families. We must take them over and, to speak frankly, nationalize them."

From the first days of their lives they will be under the healthy influence of

Communist children's nurseries and schools. There they will grow up to be real Communists."

Bolshevik education was to displace the fundamental human social unit. Teachers indoctrinated to disassociate education from thousands of years of human family experience. Does this remind us of something? Quote:

"At every hour of every day, I can tell you on which page of which book each school child in Italy is studying," boasted Benito Mussolini. On another occasion the fascist ruler declared: "It is the State which educates its citizens in civic virtue, gives them a consciousness of their mission and welds them into unity." ...

For those daring enough to challenge totalitarian overthrow of the family, Hitler had a pre-packaged response. On Nov. 6, 1933, Hitler confidently stated:

"When an opponent declares, "I will not come over to your side," I calmly say, "Your child belongs to us already.... What are you? You will pass on. Your descendants, however, now stand in the new camp. In a short time they will know nothing else but this new community."

Those 'democratic' public education systems are based on philosophy of John Dewey (USA), a follower of the German-trained Hegelian philosopher George Sylvester Morris. Be it kept in mind that George Hegel was the shared ideological godfather for collectivists of every kind.

Dewey became the great promoter of so-called American "progressive education." This, humanist and atheist viewed education as a medium for socialist

conversion and control. Lavishing praise on the Soviet school system he wrote: quote:

"That which distinguishes the Soviet system both from other national systems and from the progressive schools of other countries is the conscious control of every educational procedure by reference to a single comprehensive social purpose."

Dewey was a signer of the 1933 Humanist Manifesto. Two tenets of the manifesto state that "the universe" is "self-existing and [was] not created"; that "the traditional dualism of mind and body must be rejected." Dewey wrote: "There is no God, and no soul. Hence, there are no needs for the props of traditional religion."

[Ed. Of course not; all the props are needed for deceit of children and to prop-up the humanist religion.] The weakness of Dewey's theory was that mature adults could not be so easily tricked! It could only be introduced by indoctrination of children and mentally challenged adults. Dogma is in denial of progress.

Dogma, whether of religion or philosophy, represents death or decay of progress. Life, based on truth is progressive; though the universe die the spirit of life is eternal.

Dewey steps back to animal worship. As intelligence reveals, the fantasies of humanist theory do not fit life's reality.

As a simple illustration of Dewey's influence on public education in America, consider the syllabus Published by Purdue University's Department of Educational Studies, it states:

"Every widely held rationale for social studies education highlights the pre-

eminent role of the social studies in the preparation of these democratic citizens.... Indeed, the National Council for the Social Studies (1994) has defined the primary purpose of the field as helping "young people make informed and reasoned decisions for the public good as citizens of a culturally diverse, democratic society in an inter-dependent world." EQ.

In claim of democracy, State-controlled education will attain the same purpose no matter what the philosophy is labelled. Hitler, Mussolini or Stalin, the dictate of pretend democracy is designed to mould the children to embrace the State as god; all serve the Head of State 'as the public good' in the nature of insects.

In the system Dewey promotes all free individual development is suppressed. All so-called 'free democracies' now equally follow dogmatic socialist indoctrination in "civic virtue theology" as they evade the challenge of free human progress.

Dewey had not the intelligence to see that, in what he plans, he works with his own human potentials and what he advocates is to deny others theirs.

Egypt, bound to dogma, existed through 3 thousand years of stagnation changed only slightly by foreign interaction! Many, presented with these facts will claim that it is too much of a stretch to compare our 'democratic' public education with the systems of the Nazis, the Communists, the Fascists or the fixations of ancient Egypt.

Granted, they differ, but the difference is only that the 'more advanced' adopt improved indoctrination. The revealing equality is that there is no fence between advance and decline! While I live I grow!

Humanity can be deformed to iniquity but its pulse of life survives. Though public education in 'western' cultures now descends to disgusting child abuse (as obnoxious as that of any great dictator) in stagnation of fixed order there is no survival value.

Now the NCLBA (No Child Left Behind)

It should be clear that the NCLBA is a detailed road map for the nationalization of education in the United States. The planned new stage, "Outcome Based" education is the "end game" of a scientific "dumbing down" process. In the name of education it plans to give every child the suppression of its human abilities.

From the table of contents of the first stage NCLBA, we may read: quote:

"Title I: Improving the Academic Achievement of the Disadvantaged";
"Title II: Preparing, Training and Recruiting High Quality Teachers and Principals"; and
"Title V: Promoting Informed Parental Choice and Innovative Programs."

At first glance, one is tempted to ask...: What is wrong with seeing the "academic achievement of the disadvantaged" improved? Who wouldn't want to see their school staffed with "high quality teachers and principals"? But digging deeper into the hundreds of pages of NCLBA's text, beyond the gloss of the headlines, a more disturbing picture emerges.

In Title I, Section 1001, we read that its stated purpose is to close "the achievement gap between high- and low-performing children, especially the achievement gaps between minority and non-minority students, and between disadvantaged

children and their more advantaged peers...."

The following quotes, taken directly from Title I, Section 1111, underline the NCLBA's central theme: "the State plan shall describe a strategy for ensuring that students are taught the same knowledge and skills in such subjects and held to the same expectations as are all children"; "The academic standards required ... shall be the same academic standards that the State applies to all schools and children in the State";

"The State shall have such academic standards for all public elementary school and secondary school children ... which shall include the same knowledge, skills, and levels of achievement expected of all children." (Emphasis added.)

North Carolina state Representative Martin Nesbitt (D) sees the inherent illogicalness of this requirement: "You can't put a child who has a learning disability or other impediment in a class of 30 children and expect [it] to achieve at the level the other children achieve at." E.A. End quotes. From "No child left un-brainwashed" Jodie Gilmore.

It is so pathetic! Were previous educators sub-normal or incompetent? Can we be so easily fooled as not to see that training for uniformity of achievement set by the State can only be achieved if those of high potential are limited to the lowest? How can 'evenness' be forced other than by the suppression and oppression of those with abilities?

Do we want to spend money on teacher training and educate to eliminate challenge to State dictatorship!

This plan seriously aims to reduce all to the lowest practical level. Human normal is growth and advance; it has need of all variables and alternatives. The only equality possible is death!

The lowest common order may seem to work for a while but culture degenerates as we see in evidence today.

This has clear meaning now that we know that 'look-see' reading, 'self decided' spelling and 'total ignorance' grammar was deliberately set to achieve progressive decline in literacy. It represents *State standards* set to crush individuality and neutralize human intellect without rebellion.

He blames this result on the fact that our public school system is based on the philosophic dogma of humanism – socialist religion.

Some parents have reacted against the 'improved' "dumbing down" education, but their commitment is to modification, not elimination, they don't blockade schools, they beg for a hearing. Poll Pot killed 25%; humanism plans to kill all human development!

Looking Back! *Slavery by Law*

This essay reviews a small book, "*The Law*", written in 1850 by Frederick Bastiat (French). Translated by Dean Russell it was reprinted in 1950 to a total of near 400,000 copies by 1987. Publisher: "*The Foundation for Economic Education, inc.*," USA.

This book reveals a time when the educated analysed areas of cultural philosophy and says much that needs to be said on a subject that now needs thought.

In today's culture it seems that this human ability has died, such work is something we are unlikely to get from today's academia and it deserves recognition of modern comment.

Our world community has now been made so complicated by laws directed to social engineering that it is beyond intelligent logic. People at every level are becoming less honest, more irritable and more violent.

A return to simple exchange of social communion is needed or most of those living in our new century will suffer injustice increasing to death.

Fanatics seek to re-invent mankind but are so ignorant as to think humans should live better as ants – it should be self-evident, even to do-gooders with minds twisted to self-righteous, that in their advocacy they themselves do not behave within limits of their claimed desires of enslavement.

Social law has only one rightful purpose: to maintain freedom within limits of justice.

Isn't it now abundantly clear – with all the trouble in our world – with millions of lives destroyed by fake ideology – with protest and suffering growing by the day – that law is being used immorally?

Socialists claim that religions are the cause of most wars and we certainly have to agree with them that in recent centuries it is; unfortunately for them it is their religion/faith, "humanism", that is the worst offender. There is no evidence of any powerful philosophy in earlier times ever descending to more viscous cruelty

It should certainly be clear that those who use the law to enforce social engineering – who presume the right to shape humanity to simplistic design – who use all power of law to experiment with lives and deform all to their twisted ideas – that here is the heart of our sickness.

Social engineering is by far our most vile weapon of mass destruction for it is the cause of those other abominations. I begin with a statement made near the end of the book, *The Law*, because it sets out clearly the nature of "true human law" under the heading of:

P.71 "Justice Means Equal Rights. Quote:

Law is justice. And it would indeed be strange if law could properly be anything else! Is not justice right? Are not rights equal? By what right does the law force me to conform to the social plans of Mr. Mimral, Mr. de Melun, Mr. Thiers, or Mr. Louis Blanc?

If the law has a moral right to do this, why does it not, then, force these gentlemen to submit to "my plans"?

Is it logical to suppose that nature has not given me sufficient imagination to dream up a utopia also? "Should the law choose one fantasy among many, and put the organised force of government at its service only?"

"Law is justice. And let it not be said - as it continually is said - that under this concept, the law would be atheistic, individualistic, and heartless; that it would make mankind in its own image. This is an absurd conclusion; worthy only of those worshippers of government who believe the law IS mankind.

"Nonsense! Do those worshippers of government believe that free persons will cease to act? Does it follow that if we receive no energy [direction] from the law, we will receive no energy [direction] at all? Does it follow that if the law is restricted to the functions of protecting the free use of our faculties, we will be unable to use our faculties?"

"Suppose that the law does not force us to follow certain forms of religion or, systems of association, or methods of education, or regulations of labour, or regulations of trade, or plans for charity; does it then follow that we shall eagerly plunge into atheism, hermitary, ignorance, misery, and greed?" End Quote.

Feminists may like to know that in those times, in general use, "man" was used in the sense of 'mankind'; male and female were equal.

The importance of "The Law" is that it states a position in logic not emotion.

Most (with memory for it) see that when we lived, even if only in partial freedom

from restraints of law now accepted, we did not ignore but took more heed, of the needs of others – did not submit so totally to religious faith in political murder as now, by simple indoctrination, is sweeping the world – we were not less enterprising, less honest, less socially supportive!

The French Revolution didn't sweep the world! Deception had to worm into the minds of children to achieve success. It is unjust use of law that is dehumanising! Today 'caring' is the claimed attitude of educators but, in its result, natural caring is being replaced by an appearance of caring.

We may also see that the plunder of our wages, taken to reward those who see no need to exert themselves (law enforced charity may serve them as well or even better than their own efforts) has resulted in the demeaning or degradation of human life rather than its advance. The pleasure of self-sufficiency is being replaced by a culture of beggars.

Surely there must be questions? Do those with the arrogance to claim the right to enslave the whole of mankind for social experiment really have any such right? Why are they not classed as criminals, fools or at very least egomaniacs? What gives them right or reason to believe that they can create mankind to a better design than that of creation itself – or to endanger natural humanity?

Are they themselves not created by natural force? If creation is by chance as they claim then how is it that they think their tiny intelligence can create advance when all they offer is reduction to a lower level? By what measure are they so superior to their brothers, sisters, aunts and cousins

that they have rights of limit and control without adult agreement?

What gives their delusions the right to force of law without permission of those on whom they work their experiments? Were I to claim, and try to enforce, that people looked better without hair on their heads, I would be restrained; why are maniacs allowed law to limit the intellectual ability of my children?

Were we free within the limitations of a law that is only concerned with justice, would we not, more enthusiastically, use our abilities for study, experiment and production? Would this not advance the common good more quickly, equitably and justly, than when we are robbed of the rewards of our efforts – our enlightenment destroyed to save face of fools?

Would it not be better if everyone were encouraged to “Best Effort” rather than “dumbed-down” to least effort? Is it justice for the sick that healthy people be given the money needed for hospitals? Should the lazy be paid so we cannot afford to build safe roads? What are the consequences of law without justice?

Who benefits when culture gives false value to ego? Quote:

P.72, The Path to Dignity and Progress

“Law is justice. And it is under the law of justice - under the reign of right; under the influence of liberty, safety, stability, and responsibility – that every person will attain his real worth and the true dignity of his being. It is only under this law of justice that mankind will achieve – slowly, no doubt, but certainly – God's design for the orderly and peaceful progress of humanity.

"It seems to me that this is theoretically right, for whatever the question under discussion – whether religious, philosophical, political, or economic; whether it concerns prosperity, morality, equality, right, justice, progress, responsibility, cooperation, property, labor, trade, capital, wages, taxes, finance, population, or government – at whatever point on the scientific horizon I begin my researches, I invariably reach the same conclusion: The solution to the problem of human relationships is to be found in liberty. "E.Q.

Meaning, of course, liberties within the law of justice – nature's principles only bend so far. Bastiat must also suffer fools. *"You are doing the same thing - trying to reform society to your ideas."*

Those of clear mind will see that criticism as adolescent. Social engineers treat mankind as cattle to be changed to their desire while Bastiat says: 'Leave people with the natural limitations of moral law and they will create a greater and more rewarding culture'; he is happy to explain nature; their ego is to change nature – to be their own god.

There is a world of difference between forcing human culture to a crippled stagnation by artificial restraint or design, and of leaving culture to freely attain the highest level possible for its nature. It is the difference between slavery and freedom. However Bastiat provides his own defence:

P.74: Quote: "My attitude towards all other persons is well illustrated by this story from a celebrated traveller: He arrives one day in the midst of a tribe of savages, where a child had just been born.

A crowd of soothsayers, magicians and quacks - armed with rings, hooks, and cords, - surround it.

One said, "This child will never smell the perfume of a peace-pipe unless I stretch his nostrils." Another said: "He will never be able to hear unless I draw his ear-lobes down to his shoulders." A third said: "He will never see the sunshine unless I slant his eyes." ...

"Stop," cried the traveller. .. God has given organs to this frail creature; let them develop and grow strong by exercise, use, experience, and liberty." E. Q.

Why do we (world-wide) give social quacks a right to promote simplistic ideas for re-shaping humans? Why do we allow the blind to rob us of our individual potentials and power for independent decision-making? Why allow meddlers to restrict us to their setting? If they decline effort and do not see that our advance or decline carries them, do they prefer to destroy all? They work through children because those adult scorn their arguments?

The law is now being used to deform humanity in a way that robs all (even the I-am-god 'elite') of the right and ability to learn the truth about life and the laws of nature that apply to it.

Remember, "The Law" was written more than 150 years ago. After the French revolution and before the even more disastrous social engineering experiments in the USSR and Cambodia; socialism learning nothing, attacks through children; tricks by Hegelian Dialectic manipulation and perverts common law to make of law a farce.

If European law, even then, was so visibly perverted, how low has this creeping cancer of socialist people-shapers now brought us? Certainly the most common complaints I hear are firstly, that the law is an ass, and secondly, that the law now gives more attention to protecting the criminals than protecting the victims.

Government has no moral right to use law for social engineering! The law only one legitimate purpose and I now refer you to the book's opening statement before going to interwoven social problems:

Quote: P.5. *"The law is perverted! And the police powers of the state perverted along with it! The law, I say, not only turned from its proper purpose but made to follow an entirely contrary purpose!"*

"The law become the weapon of every kind of greed! Instead of checking crime, the law itself guilty of the evils it is supposed to punish!"

"If this is true, it is a serious fact, and moral duty requires me to call the attention of my fellow-citizens to it." E Q.

Yes, we do have that moral duty!

A/ Control freaks are driven by ego, fear and a religious faith in imagination:

B/ They use the force of the law to achieve their designs because they have no logic to convince adults.

The creation has given us, along with the miracle of life, the miracles of love, intelligence, compassion, self-awareness, and the physical means to use these gifts creatively, all far above the abilities of common animals. Who can deny our moral duty to use and defend these gifts?

Would you deny that we do not know what new miracles we may yet discover if we do use and defend these gifts? Do you deny that it would be the most detestable and cruel desecration of our potential if we should allow the most arrogant and selfish to lead future generations to stagnation and degradation?

Some feel the majority cannot be trusted. But who knows how we will respond if given knowledge and responsibility? Let's learn a little more from Frederick Bastiat:

Quote: P. 6 "What is Law?"

"What then is law? It is the collective organisation of the individual right to lawful defence. Each of us has a natural right - from God - to defend his person, his liberty, and his property. These are the three basic requirements of life, and the preservation of any one of them is completely dependent upon the preservation of the other two. For what are our faculties but the extension of our individuality? And what is property but the extension of our faculties?"

"If every person has a right to defend - even by force - his person, his liberty, and his property, then it follows that a group of men have the right to organise and support a common force to protect these rights constantly."

"Thus the principle of collective right - its reason for existing, its lawfulness - is based on individual right. And the common force that protects this collective right cannot logically have any other purpose or any other mission than that for which it acts as a substitute."

"Thus, since an individual cannot lawfully use force against the person, liberty, or

property of another individual, then the common force - for the same reason - cannot lawfully be used to destroy the person, liberty, or property of individuals or groups."

"Such a perversion of force would be, in both cases, contrary to our premise. Force has been given to us to defend our individual rights. Who will dare to say that force has been given us to destroy the equal rights of our brothers? Since no individual acting separately can lawfully use force to destroy the rights of others, does it not logically follow that the same principle also applies to the common force that is nothing more than the organised combination of the individual forces?"

"If this is true, then nothing can be more evident than this: The law is the organisation of the natural right of lawful defence. It is the substitution of a common force for individual forces. And this common force is to do only what the individual forces have a natural and lawful right to do: to protect persons, liberties, and properties; to maintain the right of each, and to cause JUSTICE to reign over us all."

P.7 "A Just and Enduring Government"

If a nation were founded on this basis, it seems to me that order would prevail among the people, in thought as well as in deed. It seems to me that such a nation would have the most simple, easy to accept, economical, limited, non-oppressive, just, and enduring government imaginable ...

P.9 "The Fatal Tendency of Mankind"

Self-preservation and self-development are common aspirations among all people. And if everyone enjoyed the

unrestricted use of his faculties and the free disposition of the fruits of his labor, social progress would be ceaseless, uninterrupted, and unending.

"But there is another tendency that is common among people. When they can, they wish to live and prosper at the expense of others. This is no rash accusation.

Nor does it come from a gloomy and uncharitable spirit. The annals of history bear witness to the truth of it: the incessant wars, mass migrations, religious persecutions, universal slavery, dishonesty in commerce, and monopolies.

"This fatal desire has its origin in the very nature of man – in that primitive, universal, and insuppressible [animal] instinct that impels him to satisfy his desires with the least possible pain.

P.10 "Property and Plunder

"Man can live and satisfy his wants only by ceaseless [continuing] labor; by the ceaseless application of his faculties to natural resources.

This process is the origin of property.

"But it is also true that a man may live and satisfy his wants by seizing and consuming the products of the labor of others. This process is the origin of plunder. [Usury]

"Now since man is naturally inclined to avoid pain – and since labor is pain in itself – it follows that men will resort to plunder whenever plunder is easier than work. History shows this quite clearly. And under these conditions, neither religion nor morality can stop it.

"When, then, does plunder stop? It stops when it becomes more painful and more dangerous than labor.

"It is evident, then, that the proper purpose of the law is to use the power of its collective force to stop this fatal tendency to plunder instead of work. All the measures of the law should protect property and punish plunder.

"But, generally, the law is made by one man or one class of men. And since law cannot operate without the sanction and support of dominating force, this force must be entrusted to those who make the laws.

"This fact, combined with the fatal tendency that exists in the heart of man to satisfy his wants with the least possible effort, explains the almost universal perversion of the law. Thus it is easy to understand how law, instead of checking injustice, becomes the invincible weapon of injustice. It is easy to understand why the law is used by the legislator to destroy in varying degrees among the rest of the people, their personal independence by slavery, their liberty by oppression, and their property by plunder. This is done for the benefit of the person who makes the law, and in proportion to the power he holds." End Quote.

Quite so! But to whom do we give power?

We, in sham democracies and republics, have been happy to give power out of our own hands and into the hands of the egocentric; the best liars and most determined to ruin the lives of others – the very ones worst fitted to lead and most likely to rob us! We then complain because they act, as we should expect.

We find one small flaw in thinking of Fred Bastiat when he says: *men will resort to plunder whenever plunder is easier than work. ... under these conditions, neither religion nor morality can stop it.* It seems to me now well proven that mankind (in general) IS quite well able to control his desire to plunder (effect usury) even when given free opportunity.

The problem is that artificial forces, more easily seen today, are discouraging of honesty. We elect the morally weak to plunder on our behalf, and the cancer grows. But let Fred himself expose the problem:

Quote: P.11 "Victims of Lawful Plunder

Men naturally rebel against the injustice of which they are victims. Thus, when plunder is organised by law for the profit of those who make the law, all the plundered classes try somehow to enter - by peaceful means or revolution - into making of laws.

"According to their degree of enlightenment, these plundered classes may propose one of two entirely different purposes when they attempt to attain political power: Either they may wish to stop lawful plunder or they may wish to share in it.

"Woe to the nation when this latter purpose prevails among the mass victims of lawful plunder when they, in turn, seize the power to make laws!

"Until that happens, the few practice lawful plunder upon the many, a common practice where the right to participate in the making of law is limited to a few persons. But then, participation in the making of law becomes universal. And

then, men seek to balance their conflicting interests by universal plunder.

"Instead of rooting out the injustices found in society, they make these injustices general. As soon as the plundered classes gain political power, they establish a system of reprisals against other classes.

*"They do not abolish legal plunder. (This objective would demand more enlightenment than they possess.) Instead, they emulate their evil predecessors by participating in this legal plunder, even though it is against their own interests.**

"It is as if it were necessary, before a reign of justice appears, for everyone to suffer a cruel retribution - some for their evilness, and some for their lack of understanding.

[*At that point we then begin to see the true socialist/communist state as we have today in disguise of capitalism. But this State is unnatural and we see it in decay. Globalists understand this but use its plausibility as temptation to gain ultimate power.]

P.12 "The Results of Legal Plunder

It is impossible to introduce into society a greater change and a greater evil than this: the conversion of the law into an instrument of plunder.

"What are the consequences of such a perversion? It would require volumes to describe them all. Thus we must content ourselves with pointing out the most striking.

"In the first place, it erases from everyone's conscience the distinction between justice and injustice. No society can exist

unless the laws are respected to a certain degree. The safest way to make laws respected is to make them respectable.

"When law and morality contradict each other, the citizen has the cruel alternative of either losing his moral sense or losing his respect for the law. These two evils are of equal consequence, and it would be difficult for a person to choose between them.

"The nature of law is to maintain justice. This is so much the case that, in the minds of the people, law and justice are one and the same thing. There is in all of us a strong disposition to believe that anything lawful is also legitimate.

"This belief is so widespread that many persons have erroneously held that things are "just" because law makes them so. Thus, in order to make plunder appear just and sacred to many consciences, it is only necessary for the law to decree and sanction it.

Slavery, restrictions, and monopoly find defenders not only among those who profit from them but also among those who suffer from them." End Quotes.

"The Law"

has its warnings now confirmed.

We see now that (to many people) law seems to make the 'moral – immoral' or the 'immoral – moral'. But we have also seen the rise and fall of *"The Union of Soviet Socialist Republics"* and the general failure of socialism. Lacking intellectual freedom, all dogma driven culture fails.

"Meanwhile the fake, in process of setting up socialism by deceit, goes from strength to strength; but did the sudden collapse of

one of the two most powerful nations seem unreal to you? By any test we live in a world that (whatever its claims) is Globalist.

Under humanist socialism even the might of the USA is now bogging down.

Globalism is the dictatorial solution to attainment of power: claim democracy, teach socialism, gain approval of the great majority and dumb-down.

P.28 "Law Is Force. Quote:

"Since the law organises justice, the socialists ask why the law should not also organise labor, education, and religion.

"Why should not law be used for those purposes?

"Because it could not organise labor, education, and religion without destroying justice. We must remember that law is force, and that, consequently, the proper functions of the law cannot lawfully extend beyond the proper functions of force.

[Socialists may once have had honest intent but not the vision to see that communism was unworkable – out of true order it needs the force and deceit of dictated stagnation. Globalism always knew what it is about: attainment of total power.]

P.28 "Law Is a Negative Concept. Quote:

The harmlessness of the mission performed by law and lawful defence is self-evident; the usefulness is obvious; and the legitimacy cannot be disputed.

But when the law, by means of its necessary agent, force, imposes on men a

regulation of labor, a method or subject of education, a religious faith or creed - then the law is no longer negative; it acts positively upon people. It substitutes the will of the legislator for their own wills or human instincts; the initiative of the legislator for their own initiatives.

"When this happens, the people no longer need to discuss, to compare, to plan ahead; the law does all this for them.

Intelligence becomes a useless drain on the people; they cease to be men; they lose their personality, their liberty, their property.

"Try to imagine a regulation of labor imposed by force that is not a violation of liberty; a transfer of wealth imposed by force that is not a violation of property. If you cannot reconcile these contradictions, then you must conclude that the law cannot organise labor and industry without organising injustice." E.Q.

If you read the whole of "The Law" you may feel irritated. A rational law of logical justice is today so far from petty indoctrination that "The Law" could hardly have been published today. So brainwashed are we to ideas of social justice that are in principle unjust, that to imagine a logical concept of law being applied now seems 'politically incorrect' and unacceptable.

But just think: at this very time an argument is being acted out between worker and employer. Now think, if you will, how deeply entrenched has become the law enforcing regulation of labour, how eagerly this has been accepted because it appears to favour the weak.

Do behind scenes forces that rule under the name of "world government" now feel they have successfully imposed such a level of ignorance and such stagnation of intelligence (as a result of their use of law as a force for regulation of education, news and public attitude) that they can now use law totally naked of justice?

Why should they not feel confident? Not only is the general public ignorant and inefficient at use of intelligence but the injustice generated by seducing a large section of the labour force (given protection of law), now allows law to be extended to total enslavement.

World government will win any contest against a commonalty bereft of knowledge. It will create divisions and increase regulation because one section of the community can be played against another until all are confused divided and totally at the mercy of Globalism.

Remember Machiavelli 500 years ago: quote *"One of the great secrets of the day is to know how to take possession of popular prejudices and passions in such a way as to introduce a confusion of principles which makes impossible all understanding between those who speak the same language and have the same interests."* E.Q. We can now believe it because we can see it?

A ratchet-like undermining of public understanding and unity, plus misuse of law, leaves the community socially confused and living in night-mares. Then, by 'gradualism' the spiral of deceit begins, generation-by-generation, like coils of a boa constrictor it squeezes, all rational response out of the community.

Without logic we can all believe as we want and so long as we avoid logical challenge we self-satisfy.

This essay views a 150-year progressive enslavement. For those who will claim that we cannot change this I offer these thoughts: "If you want change you have to begin change - if you want to go somewhere then you have to start from where you are".

This is where we are! We were brought here by incredible ego and gradualism. We, the many, by understanding and positive thought can quickly reverse this! Now let's dig a little deeper!

"Most teachers simply do not know how to reach for higher levels of thinking," says Goodlad. Indeed, they are actively discouraged from trying to do so."

"Public schooling provides the only intense experience of a public realm that most Americans will ever know. Are school buildings designed with the dignity appropriate to a great republican institution, or are most of them as crummy looking as one's own?"

"The darkness enveloping America's public schools is truly extraordinary considering that 38.9 million students attend them, that we spend nearly \$134 billion a year on them, and that foundations ladle out generous sums for the study of everything about schooling—except what really occurs in the schools.

"John I. Goodlad's eight- year investigation of a mere thirty-eight of America's 80,000 public schools—the result of which, A Place Called School, was published last year—is the most comprehensive such study ever undertaken.

"Hailed as a "landmark in American educational research," it was financed with great difficulty. The darkness, it seems, has its guardians.

"Happily, the example of Goodlad, a former dean of UCLA's Graduate School of Education, has proven contagious. A flurry of new books sheds considerable light on the practice of public education in America.

"In The Good High School:

Sara Lawrence Lightfoot offers vivid portraits" of six distinctive American secondary schools. In Horace's Compromise, Theodore R.Sizer, a former dean of Harvard's Graduate School of Education, reports on his two-year odyssey through public high schools around the country. Even High School, a

white paper issued by Ernest L. Boyer and the Carnegie Foundation for the Advancement of Teaching, is supported by a close investigation of the institutional life of a number of schools.

"Of the books under review, only *"A Nation at Risk,"* the report of the Reagan Administration's National Commission on Excellence in Education, adheres to the established practice of crass special pleading in the dark. Thanks to Goodlad et al., it is now clear what the great educational darkness has so long concealed: the depth and pervasiveness of political hypocrisy in the common schools of the country.

"The great ambition professed by public school managers is, of course, education for citizenship and self-government, which harks back to Jefferson's historic call for "general education to enable every man to judge for himself what will secure or endanger his freedom." What the public schools practice with remorseless proficiency, however, is the prevention of citizenship and the stifling of self-government.

"When 58 percent of the thirteen-year-olds tested by the National Assessment for Educational Progress think it is against the law to start a third party in America, we are dealing not with a sad educational failure but with a remarkably subtle success.

"Passive, Docile Students.

Consider how effectively America's future citizens are trained not to judge for themselves about anything. From the first grade to the twelfth, from one coast to the other, instruction in America's classrooms is almost entirely dogmatic. Answers are

"right" and answers are "wrong," but mostly answers are short.

"At all levels, [teacher-made] tests called almost exclusively for short answers and recall of information," reports Goodlad. In more than 1,000 classrooms visited by his researchers, "only rarely" was there "evidence to suggest instruction likely to go much beyond mere possession of information, to a level of understanding its implications.

[.. understanding of implications is the heart of education, without this a little knowledge can be a dangerous thing.]

"Goodlad goes on to note that "the intellectual terrain is laid out by the teacher. The paths for walking through it are largely predetermined by the teacher." The give-and-take of genuine discussion is conspicuously absent.

"Not even 1%" of instructional time, he found, was devoted to discussions that "required some kind of open response involving reasoning or perhaps an opinion from students....

"The extraordinary degree of student passivity stands out." Sizer's research substantiates Goodlad's. "No more important finding has emerged from the inquiries of our study than that the American high school student, as student, is all too often docile, compliant, and without initiative."

"There is good reason for this. On the one hand, notes Sizer, there are too few rewards for being inquisitive." On the other, the heavy emphasis on "the right answer ... smothers the student's efforts to become an effective intuitive thinker."

"Yet smothered minds are looked on with the utmost complacency by the educational establishment ... Most teachers simply do not know how to reach for higher levels of thinking," says Goodlad. Indeed, they are actively discouraged from trying to do so.

"The discouragement can be quite subtle. In their orientation talks to new, inexperienced teachers, for example, school administrators often indicate that they do not much care what happens in class so long as no noise can be heard in the hallway. This thinly veiled threat virtually ensures the prevalence of short-answer drills, workbook exercises, and the copying of long extracts from the blackboard.

These may smother young minds, but they keep the classroom Quiet.

***"Discouragement even calls itself reform.** Consider the current cry for greater use of standardized student tests to judge the "merit" of teachers and raise "academic standards." If this fake reform is foisted on the schools, dogma and docility will become even more prevalent.*

*This point is well made by Linda Darling-Hammond of the Rand Corporation in an essay in *The Great School Debate*. Where "important decisions are based on test scores," she notes, "teachers are more likely to teach to the tests" and less likely to bother with "non-tested activities, such as writing, speaking, problem-solving or real reading of real books."*

"The most influential promoter of standardized tests is the "excellence" brigade in the Department of Education; so clearly one important meaning of

"educational excellence" is greater proficiency in smothering students' efforts to think for themselves.

"Probably the greatest single discouragement to better instruction is the overcrowded classroom. The Carnegie report points out that English teachers cannot teach their students how to write when they must read and criticize the papers of as many as 175 students.

"As Sizer observes, genuine discussion is possible only in small seminars. In crowded classrooms, teachers have difficulty imparting even the most basic intellectual skills, since they have no time to give students personal attention.

"The overcrowded classroom inevitably debases instruction, yet it is the rule in America's public schools. In the first three grades of elementary school, Goodlad notes, the average class has twenty-seven students. High school classes range from twenty-five to forty students, according to the Carnegie report. [But we want better GOOD education not better bad.]

"What makes these conditions appalling is that they are quite unnecessary. The public schools are top-heavy with administrators and rife with sinecures.

"Large numbers of teachers scarcely ever set foot in a classroom, being occupied instead as grade advisers, career counsellors, "coordinators," and supervisors.

"Schools, if simply organized," Sizer writes, "can have well-paid faculty and fewer than eighty students per teacher: (16 students per class without increasing current per-pupil expenditure.)"

"Yet no serious effort is being made to reduce class size. AsSizer notes, "Reducing teacher load is, when all the negotiating is over, a low agenda item for the unions and school boards." Overcrowded classrooms virtually guarantee smothered minds, yet the subject is not even mentioned in "A Nation at Risk," for all its well-publicized braying about a "rising tide of mediocrity."

"Do the nation's educators really want to teach almost 40 million students how to "think critically," in the Carnegie report's phrase, and "how to judge for themselves," in Jefferson's? The answer is, if you can believe that you will believe anything.

"The educational establishment is not even content to produce passive minds. It seeks passive spirits as well. One effective agency for producing these is the overly populous school.

The larger schools are, the more prison-like they tend to be. In such schools, guards man the stairwells and exits. ID cards and "passes" are examined at checkpoints. Bells set off spasms of anarchy and bells quell the student mob. PA systems interrupt regularly with trivial fiats and frivolous announcements.

"This "malevolent intruder," in Sizer's apt phrase, is truly ill willed, for the PA system is actually an educational tool. It teaches the huge student mass to respect the authority of disembodied voices and the rule of remote and invisible agencies.

Sixty-three percent of all high school students in America attend schools with enrolments of 5,000 or more. The common excuse for these mobbed schools is

economy, but in fact they cannot be shown to save taxpayers a penny.

"Robert B. Hawkins Jr. in an essay in The Challenge to American Schools. Large schools "tend to create passive and compliant students," notes. That is their chief reason for being. "How can the relatively passive and docile roles of students prepare them to participate as informed, active and questioning citizens?" asks the Carnegie report, in discussing the "hidden curriculum" of passivity in the schools. The answer, they were not meant to.

"Public schools introduce future citizens to the public world, but no introduction could be more disheartening. Architecturally, public school buildings range from drab to repellent. They are often disfigured ... demoralizing neglect .."cracked sidewalks .. shabby lawn .. peeling paint..." to quote the Carnegie report. Many big-city elementary schools have numbers instead of names, making them as coldly dispiriting as possible.

"Stamping Out Republican Sentiment:

Public schools stamp out republican sentiment by habituating their students to unfairness, inequality, and special privilege. These arise inevitably from the educational establishment's longstanding policy (well described by Diane Ravitch in The Troubled Crusade) of maintaining "the correlation between social class and educational achievement."

"In order to preserve that factitious "correlation," public schooling is rigged to favor middle-class students and to ensure that working-class students do poorly enough to convince them that they fully merit the lowly station that will one

day be theirs. "Our goal is to get these kids to be like their parents," one teacher, more candid than most, remarked to a Carnegie researcher. [Early stage manipulation.]

"For more than three decades, elementary schools across the country practiced a "progressive," non-phonetic method of teaching reading that had nothing much to recommend it save its inherent social bias.

According to Ravitch, this method favored "children who were already motivated and prepared to begin reading" before entering school, while making learning to read more difficult for precisely those children whose parents were ill read or ignorant.

"The advantages enjoyed by the well-bred were thus artificially multiplied tenfold, and 23 million adult Americans are today "functional illiterates." America's educators, notes Ravitch, have "never actually accepted full responsibility for making all children literate." That describes a malicious intent a trifle too mildly.

"Reading is the key to everything else in school. Children who struggle with it in the first grade will be "grouped" with the slow readers in the second grade and will fall hopelessly behind in all subjects by the sixth. The schools hasten this process of failing behind, report Goodlad and others, by giving the best students the best teachers and struggling students the worst ones. "It is ironic," observes the Carnegie report, "that those who need the most help get the least."

"Such students are commonly diagnosed as "culturally deprived" and so are blamed for the failures inflicted on them.

Thus, they are taught to despise themselves even as they are inured to their inferior station. The whole system of unfairness, inequality, and privilege comes to fruition in high school. There, some 15.7 million youngsters are formally divided into the favored few and the ill-favored many by the practice of "tracking."

"About 35 percent of America's public secondary-school students are enrolled in academic programs (often subdivided into "gifted" and "non-gifted" tracks); the rest are relegated to some variety of non-academic schooling. Thus the tracking system, as intended, reproduces the divisions of the class system. "The honors programs," notesSizer, "serve the wealthier youngsters, and the general tracks (whatever their titles) serve the working class.

"Vocational programs are often a cruel social dumping ground." The bottom-dogs are trained for jobs as auto mechanics, cosmeticians, and institutional cooks, but they rarely get the jobs they are trained for.

"Pumping gasoline, according to the Carnegie report, is as close as an auto mechanics major is likely to get to repairing a car. "Vocational education in the schools is virtually irrelevant to job fate," asserts Goodlad. It is merely the final hoax that the school bureaucracy plays on the neediest, one that the federal government has been promoting for seventy years.

"The tracking system makes privilege and inequality blatantly visible to everyone.

"It creates under one roof "two worlds of schooling," to quote Goodlad. Students in

academic programs read Shakespeare's plays. The commonality, notes the Carnegie report, are allowed virtually no contact with serious literature. In their English classes they practice filling out job applications. "Gifted" students alone are encouraged to think for themselves. The rest are subjected to sanctimonious wind, chiefly about "work habits" and "career opportunities."

"If you are the child of low-income parents," reportsSizer, "the chances are good that you will receive limited and often careless attention from adults in your high school. If you are the child of upper-middle-income parents, chances are good that you will receive substantial and careful attention."

"In Brookline High School in Massachusetts, one of Lightfoot's "good" schools, a few fortunate students enjoy special treatment in their Advanced Placement classes. Meanwhile, students tracked into "career education" learn about "institutional cooking and clean-up" in a four-term Food Service course that requires them to mop up after their betters in the school cafeteria. This wretched arrangement expresses the true spirit of public education in America and discloses the real aim of its hidden curriculum.

"A favored few, pampered and smiled upon, are taught to cherish privilege and despise the disfavoured. The favorless many, who have majored in failure for years, are taught to think ill of themselves. Youthful spirits are broken to the world and every impulse of citizenship is effectively stifled.

"John Goodlad's judgment is severe but just: "There is in the gap between our

highly idealistic goals for schooling in our society and the differentiated opportunities condoned and supported in schools a monstrous hypocrisy."

Phony Reforms:

The public schools of America have not been corrupted for trivial reasons.

"Much would be different in a republic composed of citizens who could judge for themselves what secured or endangered their freedom. Every wielder of illicit or undemocratic power, every possessor of undue influence, every beneficiary of corrupt special privilege would find his position and tenure at hazard.

"Republican education is a menace to powerful, privileged, and influential people, and they in turn are a menace to republican education. That is why the generation that founded the public schools took care to place them under the suffrage of local communities, and that is why the corrupters of public education have virtually destroyed that suffrage.

'In 1932 there were 127,531 school districts in America. Today there are approximately 15,840 and they are virtually impotent, their proper role having been usurped by state and federal authorities.

Curriculum and text. books, methods of instruction, the procedures of the classroom, the organization of the school day, the cant, pettifoggging, and corruption are almost uniform from coast to coast.

"To put down the menace of republican education, its shield of local self-government had to be smashed, and smashed it was. The public schools we

have today are what the powerful and the considerable have made of them.

"They will not be redeemed by trifling reforms. Merit pay, a longer school year, more homework, special schools for "the gifted," and more standardized tests will not even begin to turn our public schools into nurseries of "informed, active and questioning citizens." They are not meant to.

"When the authors of A Nation at Risk call upon the schools to create an "educated work force," they are merely sanctioning the prevailing corruption, which consists precisely in the reduction of citizens to credulous workers. The education of a free people will not come from federal bureaucrats crying up "excellence" for "economic growth," any more than it came from their predecessors who cried up schooling as a means to "get a better job."

Only ordinary citizens can rescue the schools from their stifling corruption, nobody else wants ordinary children to become questioning citizens at all.

"If we wait for the mighty to teach America's youth what secures or endangers their freedom, we will wait until the crack of doom." End Quotes.

Well we waited! Readers who have read to this point will see that the whole social environment has, for years, been designed for "Dumbing Down" a whole world community, but NOT evenly. If it were attempted evenly those with advantage and power would rebel.

Give those with power some advantage where advantage is obvious to distract them from equally destructive programs

such as subversion by TV. Create obvious complaint for reactive parents so they concentrate on these and ignore more important issues.

Carefully done, those who care can be dumbed down sufficient so that they fail to see where all are being led. This allows the push to what is called "Outcome Based Education".

OBE is an accurate name for the Hegelian Dialectic principle of Thesis, Antithesis and Synthesis. Where 'thesis' is the issue of discussion; 'antithesis' is its opponent and 'synthesis' the planned outcome.

Example: Global warming: the Synthesis is the delay of action until vested interests gain the required advantage. Basically truth and untruth are balanced and managed in discussion so as to get the desired outcome.

In education 'Some much more than others', creates division within the comfort zone. Careful 'bribe' of the influential leads to feeling of gain of special privilege. Argument about 'learning environment and class size' attacks emotive problems; but do we want bad education made more effective? Occupy parents with side issues and they refrain from taking their children home?

To start the conversion of democratic education to dictatorial subversion of students political-party bigotries may serve. Eventually "Outcome-based" education reveals its purpose by its results.

Progress of this program caused considerable agitation in the US, a disquiet that reached Australia. But campaigners against "Outcomes based

Education” still do not see that this program is generations old. Parents and educators, who had the best of it earlier, may now see their children/grandchildren being crushed by the consequences.

Because those complaining are already “Dumbed-down” they do not see clearly the problem; their complaints, though loud, lack passion. They are defeated before they start because they will be satisfied with concessions that will neither stop the program nor cause it to fail.

The above may not be simply duplicated worldwide but all parents should understand that what is outlined above is the hidden goal of government-education today no matter what philosophy your system of government pretends.

There is no true democracy today.

All public education should be divorced from government control! If parents saw that their descendants will not have human-level insight: then campaigners would accept no compromise, they would inform/explain to neighbours; campaign for democracy and remove education from political control.

Government Representatives would be chosen & elected by their electorate without being first chosen to represent others or sectional-interest: “Parties”.

AIDS - A Politically Protected Disease & the World Government Plot, 1988.

With millions now dying from this disease, public awareness of human ability to create such diseases is essential!

That the AIDS threat has not yet (in advanced countries) become nearly so dangerous as feared in 1988, seems due to good fortune, awareness and hygiene. Stay alert; it may be just that those promoting this disease fear to weaken (too soon) their own power base.

Progress of AIDS in areas less developed is a revealing contrast; 2005 report 20,000,000 (twenty million) deaths and another forty million infected; later reports offer no relief.

In the main this story demonstrates:

A/ What can be done by genetic engineering;

B/ how easy the truth is hidden or confused;

We need be aware: as reported in earlier articles, such dangers multiply when combined with dumbing down to indifference and primate fixations, all should be considered in relation to increasing public misinformation about nutrition and health.

AIDS – the politically protected disease:

Politically and emotionally we help restrain ‘our’ governments. They act

irrationally in relation to AIDS as to do otherwise would challenge anti-discrimination and Human Rights agreements made with the United Nations and so challenge the philosophy to which we are indoctrinated – false philosophy made AIDS the first politically protected disease in history.

Control belief: easy manipulation!

Resistance to evidence that exposes or threatens philosophy may be revealed but we are not educated to challenge our convictions. We are educated to fear such challenge. We find it difficult to accept evidence opposed to commonly held beliefs! A weakness used by our enemies!

We don't need a book on the AIDS cover-up; just the essentials to put the plot into political perspective.

Though its worldwide progress is played down, the AIDS disaster grows. Letter to the (US) Surgeon General.

Here is part of an 'open letter' to the Surgeon-General (chief of public health in the U.S.) released at the end of a conference on Human Sexuality, held in Mexico City from April 29th to May 3rd 1987:

"Dear Surgeon-General Koop:

As health professionals, educators, counselors, clergy, parents and lay people from all walks of life, we have come together from 32 countries to defend human life and the family.

"We therefore must express to you and to the world our grave concern over the disastrously weak response of the United States Government to the deadly AIDS plague.

"Your report on AIDS, issued October 22, 1986, seriously underestimates the threat that this disease poses for the people of the United States and the world. Even worse, its recommendations for controlling the spread of AIDS will do little or nothing to stop this killer. On the contrary they are a death warrant for millions of men, women and children to whom they will give a false sense of security.

"You yourself have stated publicly that this epidemic is "the most serious matter that any health official of any nation has ever faced." You have also stated publicly that AIDS may kill 100 million people worldwide by the year 2000 - four times as many as died from the Black Plague of the Middle Ages.

"Dr. William Haseltine of the Harvard University Medical School warns that AIDS is a 'species threatening' disease.

.... We insist that you issue a new report on AIDS immediately, one that gives first priority to public health, not to the feelings of the militant homosexuals. You must tell the people of the world that:

"1. Sex with condoms is not 'Safe', contrary to your Report's assertion. Medical studies and even your own Department say these flimsy devices are only 70-90% effective... " End quote.

The letter goes on to list authorities who claim that AIDS can be spread by: kissing, coughing, contact (the virus can live for days at room temp.), blood-sucking insects etc. 6% of USA AIDS cases fitted no high risk category.

...
The disaster of AIDS is only a symptom of another social disease and unless we understand the cause we will never be safe – if AIDS does not destroy us something else will. There is more behind this disease than AIDS-related death.

The cover-up is part of a bigger picture. Do not dismiss this carelessly! New research is 'dumbed down' as millions die in less educated countries!

Although now reasonably contained in advanced countries AIDS can, at any time, be changed to more deadly potential. Your freedom, your life and the lives of those you love are at risk from diseases created by political design.

The Origin of AIDS

A report in the Sydney Morning Herald 14/12/1985, read: *"A mad scientist may have been responsible for unleashing the*

AIDS virus, an expert said to-day. Consultant Dr. Seale, a sex disease specialist, made his claim after discovering links between AIDS and the lethal VISNA virus, which attacks sheep. He believes the scientist created AIDS by mistake while experimenting with VISNA

Dr. Seal said the only difference between the two viruses was that AIDS had an extra gene, which could have been 'quite easily' inserted during experiments."

[Evidence that AIDS was deliberately designed as a killer disease by the World Health Organisation (W.H.O.) is provided by information from William Campbell Douglass, M.D. Dr. Douglass is now well known worldwide for his challenge to the "Big Pharma" pharmaceutical industry that has such influence over the modern medical industry. From the September 1987 issue of "Health Freedom News", California.

Here a paragraph from page 259 of the WHO Bulletin article referred to by Douglas; it is headed: ***"Virus-associated immunopathology: animal models and implications for human disease."*** Sub-heading- *"Effects of viruses on the immune system, immune-complex diseases, and antibody-mediated immunology injury."* Vol.47 pp 257-264]

"An attempt should be made to ascertain whether viruses can in fact exert selective effects on immune function, e. g., by depressing 7S versus 19S antibody, or by affecting T cell function as opposed to B cell function (Allison et al., 1971).

"The possibility should also be looked into that the immune response to the virus may itself be impaired if the infecting virus

damages more or less selectively the cells responding to the viral antigens.

"If this proves to be the case, virus-induced immunodepression might conceivably be highly instrumental in prolonging certain virus infections, such as murine leukemia, hepatitis, subacute sclerosing panencephalitis, or infections caused by LDV, LCMV, or ADV."

We may not understand this but we can see that there is a clear relationship with the substance of the clippings below. We learn more about the WHO later.

Whatever we may be told, the odds against AIDS being a natural disease are incredibly high (don't be misled by the idea that chance is creative), political contempt for the general population is expressed in lack of protective action.

Intent is revealed by growing evidence, now coming to light, of the unnatural spread of the disease and secrecy about the potential for manipulating any dangerous virus. We continue:

"The answer to this little mystery, 'Murder on the WHO express', will be quite clear to you by the end of my report. You will also understand why the other suspects, the homosexuals, the green monkey and the Haitians, were only pawns in this virocidal attack on the non-Communist world.

"If you believe the government propaganda that AIDS is hard to catch then you are going to die even sooner than [most] of us.

"The World Health Organisation, in published articles, called for scientists to work with these deadly agents and attempt

to make a hybrid virus that would be deadly to humans.

*"In the bulletin of the World Health Organisation (WHO), Volume 47, pp.251, * 1972, they said, 'An attempt should be made to see if viruses can in fact exert selective effects on immune function.*

*"The possibility should be looked into that the immune response to the virus itself may be impaired if the infecting virus damages, more or less selectively, the cell responding to the virus." * [Note: Given page No. error. Actual pp 257-264]*

"That's AIDS. What the WHO is saying in plain English is 'Let's cook up a virus that selectively destroys the T-cell system of man, an acquired immune deficiency.'

"Why would anyone want to do this? If you destroy the T-cell system of man you destroy man. Is it even remotely possible that the World Health Organisation would want to develop a virus that would wipe out the human race?

"If their new virus creation worked, the WHO stated, then many terrible and fatal infectious viruses could be made even more terrible and more malignant. Does this strike you as being a peculiar goal for a health organisation?

....

"AIDS started practically simultaneously in the United States, Haiti, Brazil and Central Africa.

(Was the green monkey a jet pilot?) Examination of the gene structure of the green monkey cells proves that it is not genetically possible to transfer the AIDS virus from monkeys to man by natural means.

"Because of the artificial nature of the AIDS virus it will not easily transfer from man to man until it has become very concentrated in the body fluids through repeated injections from person to person, such as drug addicts, and through high multiple partner sexuality such as takes place in Africa, among homosexuals and among native American Indians. After repeated transfer it can become a 'natural' infection for man, which it has.

[This disease had to be started in a situation of high contact so as to quickly become human specific.]

"Dr. Theodore Strecker's research of the literature indicates that the National Cancer Institute in collaboration with the World Health Organisation made the AIDS virus in their laboratories at Fort Detrick (now NCI). They combined the deadly retroviruses, bovine leukemia virus and sheep visna virus, and injected them into human tissue cultures. The result was the AIDS virus, the first human retrovirus known to man ...

"The momentous plague that we now face was anticipated by the National Academy of Sciences (NAS), in 1974 when they recommended that "Scientists throughout the world join the members of this committee in voluntarily deferring experiments [linking] animal viruses.

"What the NAS is saying in carefully guarded English is: "For God's sake stop this madness!" Man went over the edge when he started playing God and started growing human tissue in the laboratory.

...

"And what they are in the process of doing is conducting germ warfare from Fort Detrick, Maryland against the free world,

especially in the United States, even using foreign communist agents with the United States Army's germ warfare unit euphemistically called the Army Infectious Disease Unit.

"You don't believe it? Carlton Gajdusek, an NIH big-shot at Detrick admits it.

"IN THE FACILITY I HAVE A BUILDING WHERE MORE GOOD AND LOYAL COMMUNIST SCIENTISTS FROM THE USSR AND CHINA WORK, WITH FULL PASS-KEYS TO ALL THE LABORATORIES THAN THERE ARE AMERICAN. EVEN THE ARMY'S INFECTIOUS DISEASE UNIT IS LOADED WITH FOREIGN WORKERS NOT ALWAYS FRIENDLY NATIONALS."

"Can you imagine that? An UN-WHO communist Trojan horse in our biological warfare center with the full blessings of the [political leaders] of this world?

"I can assure you that the creation of the AIDS virus by the WHO was not just a diabolical scientific exercise that got out of hand. It was a cold-blooded successful attempt to create a killer virus which was then used in a successful experiment in 'third-world' countries. ...

"It was not an accident. It was deliberate. In the Federation Proceedings of the United States in 1972, WHO said: "In the relation to the immune response a number of useful experimental approaches can be visualised.

"They suggested that a neat way to do this would be to put their new killer virus (AIDS) into a vaccination program, sit back and observe the results. "This would be particularly informative in sibships," they said.

"That is, give the AIDS virus to brothers and sisters and see if they die, who dies first and of what, just like using rats in a laboratory.

"They used smallpox vaccine for their vehicle and the geographical sites chosen in 1972 were Uganda and other African states, Haiti, Brazil and Japan. "The present or recent past of AIDS epidemiology coincides with these geographical areas."

"Strecker was employed as a consultant to work on a health proposal for Security Pacific Bank. He was to estimate the cost of the health care for the future.

...

"He became fascinated with all the peculiar scientific anomalies concerning AIDS that kept cropping up. Why did the "experts" keep talking about green monkeys and homosexuals being the culprits when it was obvious that the AIDS virus was a man-made virus?

"Why did they say that it was a homosexual and drug-user disease when in Africa it was obviously a heterosexual disease? If the green monkey did it, then why did AIDS explode practically simultaneously in Africa, Haiti, Brazil, the United States and southern Japan?

"Why, when it was proposed to the National Institute of Health that the AIDS virus was a combination of two bovine or sheep viruses cultured in human cells in a

laboratory, did they say it was "bad science" when that's exactly what occurred?

"As early as 1970 the World Health Organisation was growing these deadly animal viruses in human tissue cultures. Cedric Mims, in 1981, said in a published article that there was a bovine virus contaminating the culture media of the WHO. Was this an accident or a non-accident"? If it was an accident why did WHO continue to use the vaccine?

"Dr. R.J. Biggar said in Lancet. "... The AIDS agent ... could not have originated de novo. " That means in plain English that it didn't come out of thin air. AIDS was engineered in a laboratory by virologists.

....

"What happened in 1978 and beyond to cause AIDS to burst upon the scene and devastate the homosexual segment of our population? It was the introduction of the hepatitis-B vaccine, which exhibits the exact epidemiology of AIDS.

"Doctor: W. Schmugner, born in Poland and educated in Russia, came to this country in 1969.

"Schmugner's immigration to the U.S. was probably the most fateful immigration in our history. He, by unexplained process, became head of the New York City blood bank. (How does a Russian trained doctor become head of one of the largest blood banks in the world? Doesn't that strike you as peculiar?)

"He set up the rules for the hepatitis vaccine studies. Only males between the ages of 20 and 40, who were not monogamous, would be allowed to participate in this study. Can you think of

any reason, other than the desire to spread something among the population, for insisting that all experimentees be promiscuous?

"Maybe you don't believe in communist conspiracy theory but give me some other logical explanation. Schmugner is now dead and his diabolical secret went with him.

"The hepatitis vaccine, unlike the AIDS vaccine, was not grown from human tissue culture. So accidental contamination didn't occur. The AIDS virus was probably put in the vaccine deliberately. It was no mistake.

"The Centers for Disease Control reported in 1981 that four percent of those receiving the hepatitis-vaccine were AIDS-infected- In 1984 they admitted to 60 percent. Now they refuse to give out figures at all because they don't want to admit that 100 percent of hepatitis vaccine receivers are infected ..." E quotes.

The World Government Plot.

TGA Skeletons.

WHO controls the Regulator?

We must face that health, wealth and welfare are under attack; that a large part of the growing health problem is caused by nutrient deficiency: that internationalist attack on natural foods and dietary supplements is not about money.

Now a slightly shortened, 3-Part article, on the world's largest vitamins recall and destruction: By Eve Hillary; May 12, 2003. Underline added.

Part 1.

"April 29th, 2003 was a cool autumn day in Australia. To the average Aussie it seemed a day like any other. Most tuned into the 6 o'clock news, aware that history was being made in other countries with SARS and the U.S. invasion of Iraq. But few were aware that something of historical importance was unfolding in the "Lucky Country".

"To seasoned observers ... it was nothing short of breathtaking ... dissenting voices were stunned into silence. Many pundits expected other countries to be the more likely targets but like any interesting social experiment, there was an elegant logic behind the choice. Australians were historically spared the great upheavals of the twentieth century.

"They seemed more trusting, less suspicious of political and corporate agendas than their counterparts in the northern hemisphere or in Europe where entire populations still recall the spin-doctoring of totalitarian governments under the guise of this or that benefit for the public good.

"The largest, quickest and most comprehensive recall of health care products in world history occurred in Australia following an announcement on Monday April 29th by the TGA that they had served Pan Pharmaceuticals with an order to suspend its operations for a six month period. The company supplied 75% of Australia's complementary healthcare products such as nutritional supplements in the form of vitamins, minerals, omega oils, and herbal products. ...

"Jim Selim, the founder and CEO of Pan ... has a passionate belief in natural products and expert knowledge of herbs and supplements. Selim had single handedly built up his company and within 20 years was the largest supplier of complementary health products in Australia.

"His astonishing success catapulted him onto the world stage as the fourth largest manufacturer of natural health products.

"Along with this distinction came unwanted attention from the multi-national pharmaceutical industry, which had been lobbying against natural health supplements and products because of the significant erosion they made into drug company profits.

"Studies show that 60% of consumers have spent some of their health dollars on supplements and natural remedies. Many use natural products to maintain good health or facilitate recovery from various conditions after orthodox medicine has failed, as it often does in the case of chronic illness. Doctors trained in nutritional medicine as well as qualified naturopaths; use supplements therapeutically as an adjunct to orthodox treatments or as wholistic treatments.

"The science behind natural medicine has been widely denied by orthodox medicine and is largely kept out of medical student's curricula. However nutrients have been used and studied for thousands of years and there is a large body of valid scientific evidence that shows therapeutic nutrients are highly effective in treating a wide range of conditions.

"Most health consumers take supplements because they perceive a health benefit and are not even aware that there is solid science behind nutritional therapies. This research is little mentioned in the media, which nearly always portrays nutritional therapies as being solely practiced by unqualified quacks. Media disinformation is issued directly from pharmaceutical company public relations departments on a daily basis through journalists and industry-sponsored doctors embedded in the media and other key positions.

"This has been occurring for over 40 years and is well documented in the chemical industry archives, documents released through litigation.

"Much of the public confusion on the issue results from drug industry misinformation, which frequently refers to nutrient supplements as medicines or even drugs. Nutrients are not drugs. Humans require dozens of essential nutrients such as vitamins and minerals and antioxidants to stay alive and healthy. The body knows how to use these and eliminates the excess as it has done for millions of years.

"The need for supplements has increased recently, after it has been shown that plant-based foods are now grown on barren and demineralised soils, which do not supply plants with optimum nutrients.

Humans then eat nutritionally deficient plants. Orthodox doctors claim the standard western diet contains all we need and additional supplements are 'flushed down the toilet'.

"This view appears to be myopic or at least poorly informed, given that 75% of all Australian deaths are a result of lifestyle factors. This includes poor diet and the resulting nutritional deficiencies.

"On the other hand, drugs are mostly synthetic chemicals. There are many drugs that are life saving and beneficial when prescribed responsibly. But the massive proliferation of drugs has given rise to a statistic, which the multi-national pharmaceutical industry attempts to hide. Dangerous or inappropriate pharmaceutical drug treatments and medical interventions have now become the third leading cause of death.

"The "problem" for the pharmaceutical industry is twofold. Healthy people avoid consuming pharmaceuticals. Illness generates profits to drug companies, mainly through their exclusive sale of patented drugs. Wellness and preventative medicine has been less profitable for the multinational drug industry because smaller companies like Pan and many other vitamin companies formulate and sell most of the world's nutritional and vitamin products.

"Nutrients and herbs are naturally occurring substances and therefore cannot be patented unless their structure is changed through genetic engineering or chemical processes. Pharmaceutical industry PR departments and industry-funded scientists have been behind unnecessary herb and vitamin scares,

citing lack of uniformity or actual danger to persons who take supplements.

"Subsequently natural products have been withdrawn from sale while massive drug and biotech multi-nationals work behind the scenes to chemically alter and patent natural substances as pharmaceuticals. In Australia alone the increasing popularity of natural products has deprived the global pharmaceutical market of 2 billion dollars annually. This has brought in its wake an accelerating clampdown on complementary medicine (using natural products). The drug industry is worth trillions of dollars worldwide and it has some powerful friends.

"In January 2003, the TGA moved to recall Travacalm, Pan's over-the-counter travel sickness tablet when it was tested and found to be defective. After the January recall, Pan discovered a problem with one of its analysts whom the company claimed was responsible for the lapse in quality control over the defective product.

The company dismissed the analyst, and set out to correct the problem with its recalled product, while continuing to manufacture its other unaffected product lines. So far the protocol followed normal procedure for a recall, a commonplace occurrence even in the multi-national pharmaceutical industry.

"However, neither Jim Selim nor Pan's board members anticipated the special attention they were about to receive from the TGA. The company had become used to the regular TGA inspections in the previous few years and neither Pan nor the TGA found any serious cause for concern.

"In fact, Pan's vitamin and herb factory had been inspected more often and more rigorously than the Australian-based operations of multi-national pharmaceutical drug companies. However, after January the TGA conducted a number of audit raids on Pan which foreshadowed trouble.

"In April, the TGA shut down Pan's entire operation and slapped a class 1 recall over 1369 Pan products which were unrelated to Travacalm. This involved mostly vitamins, minerals and herbal products, which the company supplied to over 75% of the complementary health care market. The regulator cited serious concerns as to the quality, safety or effectiveness of these natural remedies.

"Class 1 recalls are only issued when it has been shown that the product is likely to cause serious, irreversible health damage or death.

"By its extreme action of issuing a class 1 recall, the TGA indicated to the general public that the calcium tablet or vitamin C or Echinacea or chamomile or any other of the 1369 natural products they had been taking without any problems, are now expected to cause death or irreversible health damage.

"Many consumers questioned this logic when they had experienced no adverse health effects from the supplements they had already taken. Those whose suspicions were aroused were even more surprised that the TGA had not given specific information about the nature of the problem with the products.

"Then Mayne Health, a large health care company whom Pan supplied with health

care products, stated that their company had regularly conducted their own rigorous testing of Pan's product and had not found a cause for concern.

"The TGA offered no explanation as to why an independent distributor of Pan's products could find no problem on testing when the regulator claimed there was a life-threatening problem.

"During the week of the shock announcement, TGA left its responsibilities as a provider of accurate and useful public information, to the daily tabloids who rushed to fill the information vacuum with headlines such as; Honeymoon Ruined, Babies in Danger, It's a Sick Business, Bad Medicine.

"By the end of the week the TGA had still not explained the specific problem and which of the vitamin company's products were affected and in what way. Instead they stood by as the press had a field day whipping up the story while the more vulnerable consumers of health care products, elderly people and young mothers, panicked and imagined all types of horrific scenarios.

"The interim week saw a run on 5000 health food stores which reported an influx of panicked customers demanding refunds for all manner of products, even those they'd fully consumed, and those that were out of date. Some demanded money for taxi fares.

"The TGA remained tight lipped about the offending substance that had allegedly rendered these supplements life threatening overnight. Instead, the regulator issued numerous public announcements stating that; "drugs and

pharmaceuticals are perfectly safe and persons should keep on taking them". The NSW State Premier chimed in with his own message to that effect.

"By the end of the week the dailies continued running weekend feature stories about the grave dangers of taking vitamins. The conundrum sent freelance and independent researchers scurrying to their computers to research product recalls.

"A short search of the FDA drug recall list and medico-legal websites, list thousands of recalls, adverse events and warnings pertaining to drug and chemical products manufactured by multi-national drug and chemical companies. Many of the listed products are known to be either dangerous or toxic to humans and even carcinogenic.

"Multi-national drug company recalls are rarely given much press, and have never been given as much negative media attention as Pan had received.

"Even more incredibly, no large multi-national company has ever been shut down by a government regulator after one of its products has been recalled, even if deaths have occurred as a result of using the drug or chemical. This discovery was guaranteed to make any independent journalist even more curious about the TGA and the vitamin company.

"In the second week, Pan stocks plummeted and other companies scrambled to fill the manufacturing gap while their share prices surfed a rising wave.

"The mainstream media had settled into the role of investigators and de-facto TGA

spokespersons, breathlessly informing the public of the "facts" behind the "vitamin scandal". "Snake Oil Jim Quits.." screamed the tabloids, while the "prestigious" Sydney Morning Herald ran the story; "Tangled Tale of Lucky Jim", a vicious little expose` of Selim's daughter and her 1997 battle with drugs. Any parent would consider it a tragedy to watch their child suffer from the disease of addiction, let alone have it published

"The journalists Mercer and Stevenson used a psychologist's report to speculate on Jim Selim's shortcomings as a parent. Hardly a need-to-know issue for the Australian public who had still not been informed as to the results of the regulator's testing of the 1369 urgently recalled products Jim Selim voluntarily resigned as CEO from his own company, amidst one of the most vicious tabloid vilification campaigns in the history of the Australian press.

"While grannies thought they had been poisoned, Australia's investigative journalists wrote about interviews with disgruntled employees who thought they should have had longer breaks and the production should have been slower at the vitamin factory. The dailies stated opinion as gospel while offering no real facts from the TGA.

"While the thinking public waited for the facts, young mothers still thought they had poisoned their babies. The tabloids made fun of Jim Selim and columnists wrote ditties about vitamins and herbs being "eye of newt".

"Embedded industry-sponsored TV journalists worked feverishly behind the scenes to spin horror exposés about herbs

and vitamins that were screened within a week of the breaking news. "And still no one had suffered any adverse effects from having taken vitamins.

"Embedded "experts" emerged from the closet with their editorials, published under the guise of objective articles. Still the TGA remained silent about the exact reason why the natural products were classed as being capable of causing death. Pundits assumed TGA was checking all recalled products just as they had checked Travacalm and made public the exact nature of the problem.

"By the end of the week Jim Selim, once a man with a zest for life, had been forced to leave his home after journalists crawled all over his garden by day and night. They interviewed his neighbours, one of whom complained that the Selim family had visitors who banged the gate when they left. The other complaint was about the noise when the family swam in their pool. The facts gleaned by the reader from this in-depth investigative journalism were that the Selims had friends and they indulged in occasional exercise. ...

"While the media was beating itself to death with the vitamin factory story, a little known posting appeared in an obscure place on the TGA website. The regulator is also in charge of being a public watchdog with respect to food, chemicals and consumer items.

"On the same day as the TGA recalled Pan products, they also issued another recall. A small goods company packaged a large quantity of ham, which was found to be contaminated with bacteria known to cause serious food poisoning, which sometimes results in death.

"The media never mentioned this, and there were no public press releases issued by the TGA.

"At the end of the second week following the world's largest recall, the TGA had still released no results of their product testing to Australian consumers or the thousands of businesses that relied on accurate information. But many of the 5000 or so Australian health food store proprietors were about to start the cascade into insolvency.

"To hasten the process, they were forced by the consumer watchdog ACCC to issue consumer refunds when they had no guarantee of reimbursement by the now ailing manufacturer.

"Health food shops were left saddled with the difference between the wholesale and retail price, which they had to find out of their own pockets.

"With their backs to the wall they still had precious little by way of an explanation. However, TGA did issue clear instructions to clear shelves of recalled product. ...

"The largest mountain of vitamins, minerals, oils and herbs in the world was hurriedly designated for destruction by the Australian Government in a special location and using a special process usually reserved for toxic waste. The evidence is destined for destruction.

"The TGA has still not informed the public as to why their natural products were classified as being deadly, when no one had previously suffered adverse effects. The regulator has released no test results. It is not known if tests were ever conducted.

"When the mountain of vitamins finally rests in its mass grave, incinerated and entombed as the remains of what the Australian government regards as toxic waste, we will never know. And the epitaph on the headstone could well read; "Here Lies Health Freedom".

"Among the mystery and intrigue surrounding this historical event, one thing appears to be certain. Had any test shown a lethal toxicity supporting a Class 1 recall, the TGA would have told us by now.

"Unlike some issues that rest in peace, the ghost of this recall will haunt the government for years to come. The story of the recall started years ago in a bustling European city. But first, a little more about the regulator.

Part 2.

TGA "Protecting the Health and Safety of All Australians"

"Like its US FDA counterpart, the Australian TGA states that it "is obligated to take action where there is concern in relation to the quality, safety and effectiveness of medicines." The regulator also oversees the safety of food and chemical products as well as consumer items and medicines.

"The TGA states its role is to "...protect the health and safety of all Australians." However, an audit of the regulator's performance reveals an astonishing picture.

TGA Regulating Chemicals

"In 1999 a woman lodged a complaint with the TGA about a chemical product that she had used, as directed on the label.

Using this product had caused her to be violently ill and she required hospital treatment. She was pregnant at the time of the toxic exposure.

"Serious health effects became apparent as a result of the poisoning affecting both the woman and her child for many years.

Both were subsequently diagnosed with chemical poisoning by two Australian doctors and one U.S. specialist physician.

"She reported this to the then director of the Chemicals and Non-prescription Medicines Branch of the TGA, Mr. Graham Peachey.

"The director replied to her complaint, claiming that all chemicals are rigorously tested and regulated by Australian government departments.

He maintained that her claim that this chemical product had caused serious illness was a result of "a strong interaction with personal belief factors".

"By this, he dismissed her complaint, alleging that she was imagining the (medically diagnosed) serious effects the chemical exposure had on herself and her child.

The woman wrote back enquiring as to what kind of testing is done by the regulators on toxic chemicals that are manufactured by large multi-national companies and that stream directly onto the Australian market.

"She received no reply. She later found out that no independent testing of any kind is done on these products before they reach the consumer.

"Meanwhile she encountered others who'd had similar experiences with the same chemical and other toxic consumer products. She discovered that they too had written letters of complaint to the TGA, and they had received the same response. She joined a support group for chemically injured persons, and became the group's newsletter editor.

"Soon she was inundated with letters from persons who related the identical or similar responses from the TGA after they had lodged complaints to the regulator about harmful effects from toxic chemicals in consumer products.

"Intrigued she investigated these allegations and found that the TGA had dismissed all of them. None of these dozens (and possibly thousands) of complaints alleging serious and sometimes life threatening effects on consumers by various chemical products were ever investigated by the TGA.

"The multi-national chemical manufacturers were never held accountable and the TGA never co-operated with calls to start an adverse events register for chemical products despite years of lobbying by individuals, advocates and support groups.

TGA Regulating Drugs

"Like its U.S. FDA counterpart, the TGA regulates and approves drugs.

"Ten years ago in 1994 there were 157.5 million prescriptions issued annually. That figure has now increased exponentially as hundreds of new drugs have come on line. It would be reasonable to assume that a large part of the huge modern TGA building in Canberra would be devoted to ensuring public safety

through monitoring of potent pharmaceutical drugs. However more oversight committees and manpower is devoted to herbs and vitamins.

"Why? A quick overview of just one drug regulating example will yield some disturbing answers and raise even more questions.

"In the mid 1980's GlaxoSmithKline marketed bupropion as an antidepressant, released under the brand name of Wellbutrin and later Zyban.

"In 1986 bupropion was briefly withdrawn due to the high rate of convulsions associated with its use, and later inexplicably returned to the marketplace.

"By 2002 bupropion was recognised as the third most common cause of drug related seizures with cocaine found to be the number one cause (2). Bupropion is often placed in the same category as Prozac type drugs, but its exact mode of action remains unclear after many years of study. Since 1998, statistics indicated some serious adverse effects were occurring among patients taking the drug.

"Complaints were flowing in to Health Canada, to the UK regulator and to the manufacturer, GlaxoSmithKline. The company had received 1127 adverse reports about the drug from Canada alone between May 1998 and May 28, 2001.

"This included 19 deaths. Meanwhile the Medicines Control Agency, UK's version of the FDA/TGA, reported 3,457 adverse reaction reports to the drug including 18 deaths. Since then there have been 7,500 adverse reactions and 58 deaths in the UK up to April 2002.

"In 2000, GlaxoSmithKline lodged an application to the TGA to approve bupropion, to be marketed in its new guise, not as an anti-depressant, but as an anti smoking drug called Zyban. By then the drug had collected a number of skeletons in its closet.

"The drug had enjoyed another life as a weight loss pill, and was written up in an Obesity Journal as being a fat buster, since loss of appetite had been determined in 3% of the side effects reported while in use as an antidepressant.

"However, the "research" was far from ethical, as it was commissioned and paid for by the drug's manufacturer. (3,4) Shortly after the pharmaceutical giant lodged its drug application to the TGA in Canberra the regulator commenced its stringent "pre-market evaluation" of bupropion, now known as Zyban. The registration process involved an in depth assessment of the drug, its efficacy, and safety.

"The regulator was required to review the adverse effects including convulsions and death associated with the drug's use overseas, figures that were by then readily available.

"While the TGA was still busy "protecting the health and safety of all Australians" with its rigorous safety assessment of the drug, the global death toll was still escalating.

"By mid 2002 the manufacturer had already received reports of 245 deaths associated with the use of this drug. (5) After the TGA experts finished their stringent review of bupropion, now marketed Zyban, the drug enjoyed the

approval of the Australian regulator. It was introduced into Australia late in 2000, and extensively promoted to doctors as an anti smoking drug (1).

"The Australian Zyban experience proved to be tragically identical to the reported overseas experience. Not long after TGA approved its use in Australia serious reports of adverse reactions started to pour into the TGA's adverse drug reactions advisory committee ADRAC. Since Zyban's approval, 1237 reports of adverse reactions linked to Zyban, have been reported to the TGA, including: 74 episodes of convulsions/twitching, psychiatric effects such as depression and anxiety, serious skin rashes including a serum sickness type syndrome, impotence, chest pain. And 18 Australians died. (1)

"When complaints came into the adverse drug advisory committee about Pan's Travacalm after persons experienced ... side effects from the product, the TGA perhaps understandably applied a class 1 recall, even though there were no irreversible effects or deaths. (Class 2 recall is in case of adverse events that are reversible or mild, and class 3 recalls are reserved when no serious adverse events are expected to occur) Oddly the vitamins included in this recent haul attracted a Class 1 recall when no effects at all had been reported.

"However, despite the high numbers of adverse events and deaths, the TGA has no serious concerns about the safety of Zyban.

"To protect the health and safety of all Australians the regulator will review "each report with a fatal outcome" through its ADRAC (adverse drug

reactions advisory committee), which meets every six to seven weeks and "is keeping the drug's safety under close review."

"The committee's experts are not certain as to whether the deaths and serious side effects are caused by the drug or are "coincidental." (1) [Ed. Isn't that why they are supposed to do independent tests?]

"While the TGA is still "reviewing" and "monitoring" the ever-increasing death toll linked to an apparently dangerous drug, it has acted immediately to affect a class 1 recall of a calcium supplement, which it recalls "Due to serious concerns".

Calcium is a naturally occurring mineral that is required for good health on a daily basis, and no one has ever died from it.

"Closely followed by a class 1 recall of 1369 other natural supplements. The regulator has no plans to withdraw Zyban from the Australian market. It is not the only dangerous drug widely prescribed and approved by the TGA. 10,000 fatal events occur annually in Australia, attributed to medical procedures and drug associated deaths. Most of these deaths could have been avoided if the regulator recalled the drugs that caused deaths and left the vitamins and nutrients essential to life available to the public.

"The disturbing questions raised by this paradox must now be answered.

Part 3. WHO owns the TGA?

"Each year delegates gather in a European city to convene the Codex Alimentarius Commission. The first commission was convened in 1963 as a

joint effort between the UN and the WHO (world health organization).

"Since that time the Codex delegates have overwhelmingly represented large multi national pharmaceutical companies and government regulating authorities including the FDA and TGA.

"The delegates are determining an eight step guideline that is already being implemented in many countries of the world. The Codex guidelines are intended to prevent the further sale of supplements and herbs and to regulate them as drugs to be manufactured solely by drug companies.

"In accord with the Codex guidelines, supplements are being slowly withdrawn from the public domain.

"There are no representatives of small vitamin manufacturers and retailers at Codex meetings and health supplement consumers are not represented, as they are not eligible to attend. There is no press allowed during these meetings. Each successive meeting at the Codex commission advances the coming agenda to set worldwide guidelines on vitamins, supplements and herbs.

"The full restriction of supplements and herbs is enacted as an eight-step process and begins with seemingly innocent changes that the regulator adopts at first.

Finally each country is brought closer to full harmonisation when the consumer can no longer access supplements or herbs.

"The guidelines include the setting of recommended daily intake (RDI) levels of supplements, which are set so low as to make therapeutic doses or prophylactic

doses of supplements impossible and technically illegal.

"Iceland, Sweden, Norway and Denmark have already harmonised to step 5. Once harmonised, the codex 'recommendation' becomes enshrined in that country's statutes and laws are strictly observed. One Scandinavian vitamin supplier was chased by the federal police for supplying vitamin C tablets that exceeded 200 mg. The amount of vitamin C contained in three oranges had made this man a criminal.

"Canada has recently harmonised with Codex, with its regulator withdrawing nearly half of the stocks in health food stores overnight.

"Possession of one popular supplement DHEA in Canada now attracts the same penalties as crack cocaine. The Canadian regulator is empowered to classify any substance as a drug and it makes no difference if that substance is a food that has been consumed for millions of years and is perfectly safe. That product can be recalled or removed from the market.

"As Codex continues its march, herbs are increasingly classed as drugs with restricted access. Germany has already complied fully by regulating all supplements and herbs as drugs. In a country with an age-old tradition of natural medicine, no one can freely access these products now.

"This is designed to assist drug companies in their technology of PharmaPrinting, which produces versions of herbs that will be standardized and patented by drug companies and approved by government regulators as drugs. In a press release six years ago, the WHO has announced its

collaboration with PharmaPrint, a California based Biotech Company, which has already started to standardise useful herbs such as Gingko, St. John's Wart, Valerian and many others. (9)

"Once patented, useful Herbs will then be banned and removed from the public domain, even for garden use. There has already been a Federal police raid carried out on a couple in northern NSW who planted a Chinese herb in their garden to use as tea. (10)

"For the time being, all herbs and supplements have now been allocated DIN (drug identification numbers) which many regulators have now adopted and implemented in their respective countries as they gradually harmonise with the codex recommendations". Australian TGA officials have distributed much of this DIN software to other countries.

"The TGA is in the process of pressuring New Zealand to adopt similar restrictive standards as are currently in Australia.

"Graham Peachey, the one time director of the chemicals and non-prescription medicines branch of the TGA has taken over the task of persuading NZ to harmonise to the same level as Australia.

That includes the prohibition of any therapeutic claim made with respect to nutritional supplements, even if there exist medical studies to support those claims.

"So far NZ has resisted moves in that direction, placing value on health freedom for its citizens. However, failure to implement these Codex standards will result in sanctions against governments by the WTO.

"There is a fortune to be made by multinational drug companies solely controlling the manufacture and sale of all life sustaining natural products. [Ed. This is a good cover but not good enough to explain mass murder sanctioned by democratic governments.]

"Many doctors and health freedom advocates are deeply disturbed by these events. Dr. Matthias Rath, a medical specialist in nutritional medicine demonstrated that nutritional supplements reversed many conditions including heart disease.

"He states. "If the Codex Commission is allowed to obstruct the eradication of heart disease by restricting access to nutritional supplements, more than 12 million people world-wide will continue to die every year from premature heart attacks and strokes. Within the next generation alone, this would result in over 300 million premature deaths, more than in all the wars of mankind together."

"Codex has been a well-kept secret for many years. However, lately word has spread and thousands of health conscious and informed people are protesting against the disappearance of health freedom.

"People are demanding their right to stay healthy in open demonstrations around the world. For countries that have already harmonised, it is too late to reverse this blow to health freedom in the near future. ...

Back to Pan

"It seems an extraordinary stroke of luck for the TGA that half the supplement stocks have been swept away into a toxic waste incinerator while the media

manufactures public consent for the regulator to clamp down on the vitamin industry with tighter controls.

"Clean up the industry" the public demands. "Standardise herbs". "Tighten up the regulations", demand those who know nothing of the global agenda, and the same cry is heard from those who know the plan. Many senior TGA officials have deep ties to WHO (World Health Organization). News of Pan travels fast. It was posted in Geneva the day after it was announced to Australians.

"We would be well advised to watch the developments from now on. And to speak up while we still can. We are nearing midnight, just a few short steps away from "harmonising" with the needs of a very powerful cadre of individuals. It was Benito Mussolini who said, "Fascism should more appropriately be called corporatism because it is a merger of state and corporate power."

"In the lucky country people still believe Benito lived a long time ago in a land far away.

"After WW2, the 27 American TV companies including Zenith, Emerson, RCA, GE, etc. led the world in TV technology. Then, the owners of the patents on TV technology decided they didn't need to dirty their hands by actually making the TV sets themselves any more, and they started selling licenses to manufacture, which the Japanese bought.

"By 1987, the only remaining American TV company is Zenith. The patent holders get their money, but the American products which can be sold overseas are gone, along with the jobs to make them.

"The same happened in high-tech electronics. The integrated circuit was invented in the United States. But rather than focus on selling integrated circuits, the companies that owned that technology sold the machines to MAKE integrated circuits around the world, and now America sells very few chips anywhere. The patent holders have their money, but the cash flow from sales of manufactured goods, and the jobs that go with them, are gone. ..."

"The airplane was invented in the United States, and through the 60s, we sold a lot of them around the world. But lately, all aircraft sales to foreign countries involve "offsets", a portion of the core technology that gets licensed to the purchasing nation and gets manufactured there. Bit by bit, the core technology gets bled off, taking with it jobs, and cash flow from the sale of those manufactured products.

"Along the way, the rights to manufacture American inventions outside America leak away on a steadily increasing basis. Even the mighty F-16 is now being manufactured overseas, under license.

"To cover the loss of manufacturing jobs, government has invented the catch phrase "service economy". This is the idiotic notion that we don't need to actually sell manufactured products; that we can grow and prosper our nation by doing each other's laundry.

"To conceal the loss of manufacturing jobs, the government has legislated into existence thousands upon thousands of useless paper-shuffling jobs, and declared their necessity by fiat.

"The most obvious is the income tax which has been so obfuscated by the government that half of you had to rely on an outside expert to figure out just what all those incomprehensible words really meant.

By this device, the government has replaced those jobs that made products to sell with an equal number of jobs that produce nothing whatsoever of any worth, except to keep the unemployment figures down.

"This over-burdening of the American people with gratuitous regulations and

paperwork has accomplished nothing except to obfuscate the loss of manufacturing jobs, and to transform the American character from innovators and inventors creating new products to that of minor clerks, peeking under each other's seat cushions for lost change.

"So, with most of our manufacturing now gone, just what DOES America make? Trouble, mostly.

"With 4% of the world's population and 18% of the economy, we have 50% of all the lawyers, all looking to make a killing by looting those few industries that still call America home Kids don't want to be scientists and engineers; they've seen how little such people are valued in our country.

"Based on recent history, kids see the "big bucks" are in corporate law, specifically investment banking, leveraged buyouts, greenmail, junk bonds, in short what other countries describe as "trying to make money grow by shaking it side to side.*

*[*Let's not forget 'sport', entertainment and tourism.]*

...

"So, what do all these countries on the plus side of the trade imbalance do with their surplus billions? Well, they have been loaning it right back to us!

[Smart lenders are now taking money out and the value of the US \$ is dropping. If we do not destroy the myth then the myth destroys us. Ed.]

"Our government engages in a practice politely called "deficit spending". Other terms which would aptly describe the practice include "check kiting" and

"counterfeiting", but it all comes down to the same thing; spending money one does not actually have.

"What would be a jailable offence for a normal citizen was rendered legal for the government by the Federal Reserve Act. This was not a popular piece of legislation. In fact the Democrats had campaigned in 1912 on a platform of rejection of the creation of a private bank in charge of a fiat money system.

"Nevertheless, on December 23, 1913, taking advantage of the absence of congressmen opposed to the creation of a fiat monetary system during the Christmas break, the Federal Reserve Act was passed. ...

"Years later, during the great depression, Congressman Louis T. McFadden (who served twelve years as Chairman of the Committee on Banking and Currency) asked for congressional investigations of criminal conspiracy to establish the privately owned 'Federal Reserve System'.

*"He requested impeachment of Federal officers who had violated oaths of office both in establishing and directing the Federal Reserve – imploring Congress to investigate an incredible scope of overt criminal acts by the Federal Reserve Board and Federal Reserve Banks. **

a) McFadden even suggested that the Federal Reserve deliberately triggered the great stock market crash of 1929, in order to eventually force the passage of the Emergency Banking Act of March 9, 1933, which suspended the gold standard.

"In describing the FED, McFadden remarked in the Congressional Record,

House pages 1295 and 1296 on June 10, 1932:

"Mr. Chairman, we have in this country one of the most corrupt institutions the world has ever known. I refer to the Federal Reserve Board and the Federal Reserve banks.

"The Federal Reserve Board, a Government Board, has cheated the Government of the United States and the people of the United States out of enough money to pay the national debt.

"The depredations and the iniquities of the Federal Reserve Board and the Federal reserve banks acting together have cost this country enough money to pay the national debt several times over. This evil institution has impoverished and ruined the people of the United States; has bankrupted itself, and has practically bankrupted our Government. It has done this through the misadministration of that law by which the Federal Reserve Board, and through the corrupt practices of the moneyed vultures who control it".

[That was in 1932; we know the USA government had bowed to the money managers in 1908 so who would stand firm in 1932. However the planned rip-off was kept on ice for another 50 years. This partly so we, the people, would have time to forget the terrible consequences that could result, but more important, to set up the final collapse and takeover being planned.

So we, in our indoctrinated majority, are now convinced our 'democratic' government would not deliberately destroy us, financially, morally or in any other way. The more glaringly obvious the tragedy the more tightly we close our eyes.

Now unable to believe our government is not genuinely democratic we cannot believe that we (democratically governed) make of ourselves poor, powerless, pathetic and (soon to be) passed away!

The Gold Standard

"Why all the fuss over the gold standard? Well it goes back to the original Founding Fathers and the meaning of the word "dollar". "Dollar" is actually a weight measure of silver, 371.25 grains, to be exact.

"Our American silver dollars are actually heavier, since other metals were added for durability. But that 371.25 grains of silver WAS the dollar, matching in weight an unbroken chain of accepted monetary units that reached back through the Spanish Milled Dollar, the Dutch Daller, back to the German Thaler; the product of a silver mine which sold it's product in coins of an exact weight.

"The Coinage Act of 1792 defined our dollar to exactly match in weight the silver dollars in use around the world, and then defined the gold dollar to be that amount of gold which would equal the worth of silver in a silver dollar, 24.75 grains, 1/15 the weight of the silver in a silver dollar.

"So, what's wrong with this? Nothing really. When you, as a citizen, hold a silver dollar or a gold dollar in our hand, you hold that actual worth of metal. Nothing the government can do can change the worth of the money in your control. ...

"Of course, carrying around too much coin can be bothersome, so many nations, including our own, issued paper notes as

a convenience. But that paper currency of the nation was just a convenience.

"The gold and silver certificates were merely "claim checks" for the equivalent weight of gold or silver held in the treasury, and which would be produced on demand when the certificate was presented. ...

"The problem with this system from the point of view of the government or the banks is that it limits the amount of money they can work with. When the bank runs out of silver or gold (or the equivalent certificates) it can no longer lend any more money with which to earn interest. When the government runs out of gold or silver (or the equivalent certificates) it can no longer spend money (just like the rest of us).

"The immediate effect of ending the gold standard was that with the paper dollar no longer legally dependent on 371.25 in silver or 24.75 grains of gold, more paper dollars (now called "Federal Reserve Notes") could be printed, their worth no longer under the control of the citizens but under the control of the issuing central bank, based on the total number of dollars printed (or created as credit lines).

"The more dollars, which are created out of thin air, the less each one is worth.

[Yes, I repeat again, the Federal Reserve Bank is privately owned and effectively controls the world economy; the Federal Reserve Board is of the government but bows to the bankers.

The government appoints the head of the bank but it, as we now know, is owned (controlled) by the Bankers.]

"A Federal Reserve Note.

The swindle of the system is simple. The Federal Reserve Bank hires the US Treasury to print up some money. The Federal Reserve only actually pays the treasury for the cost of the printing, they do NOT pay \$1 for each 1\$ printed. But the Federal Reserve turns around and loans out that money (or credit line) to banks at full face value, those banks which have exhausted their deposits then loan that Federal Reserve fiat money to you, and you must repay it in the full dollar value (plus interest) in work product, even though the Federal Reserve printed that money for pennies, or created it out of thin air in a computer.

"As the Federal Reserve overprints more money, the money supply inflates, and too much money starts chasing too few goods and services, so prices go up. But contrary to the charade put on by the Federal Reserve, inflation doesn't just come and go due to some arcane sorcery. The Federal Reserve can halt inflation any time it wants to by simply shutting down those printing presses. It therefore follows that both inflation and recession are fully under the control of the Federal Reserve.

"Over time, that excess of printing has destroyed the value of that dollar you think you have. If you want to know by just how much, go out and try to purchase 371.25 in silver right now. Usually, the deterioration is gradual. Sometimes, it has to be obvious, such as the 1985 devaluation (done to halt the trade imbalance), which triggered the Japanese real-estate grab in this country.

"Many [well some] politicians have attempted to reverse this process. John F. Kennedy issued an Executive Order

11110, requiring the Treasury Department to start printing and issuing silver certificates for the silver then remaining in the US Treasury.

*"Kennedy decided that by returning to the constitution, which states that only Congress shall coin and regulate money, the soaring national debt could be reduced by not paying interest to the bankers of the Federal Reserve System, who print paper money then loan it to the government at interest. This was the reason he signed Executive Order 11110 which called for the issuance of \$4,292,893,815 in United States Notes through the U.S. Treasury rather than the traditional Federal Reserve System. ***

"John F. Kennedy's United States Note.

That same day, Kennedy signed a bill changing the backing of one and two dollar bills from silver to gold, adding strength to the weakened U.S. currency.

"Kennedy's comptroller of the currency, James J. Saxon, had been at odds with the powerful Federal Reserve Board for some time, encouraging broader investment and lending powers for banks that were not part of the Federal Reserve system. Saxon also had decided that non-Reserve banks could underwrite state and local general obligation bonds, again weakening the dominant Federal Reserve banks".

**b Kennedy's E.O. [Executive Order] was never implemented following his assassination, and shortly afterwards, United States silver coins were taken out of circulation and replaced with the copper clad slugs in use today.*

"These two events, the failure to print new silver certificates, and the substitution of

worthless slugs for our silver coins, may explain why the Warren Commission included on its panel John J. McCloy, a man with no experience in crime, law enforcement, or national security, but who had been the President of the Chase Manhattan Bank.

It should be noted that the banks themselves are still using the gold standard. Accounts are still settled between major national banks by the transfer of gold bullion.

"So here we are with a privately owned bank that legally counterfeits the money you borrow but expects a full value (plus interest) repayment. But what's good for the Federal Reserve is good for the government itself, and this is where we get back into that funny word "deficit spending". The government spends more money than it takes in. It has for many years now.

"The Federal Reserve, being the only 'lawful' source of this fiat (unlawful) money, prints up the excess cash the government needs (or manufactures a credit line in a computer). This extra cash is treated as a loan, in order to keep the government overspending from further eroding the worth of the dollar in the world market. The government (meaning the taxpayers) is on the hook for the full face value, plus interest.

...

"In order to keep the jobless rate low, a massive defense program called the Strategic Defense Initiative was cranked up, but since this program produced no exportable product, it produced no taxable sales revenues, and hence the money poured into the project accelerated the government decline into debt.

"Because manufacturing was on the decline, fewer start-up companies were approaching the lending institutions, so the government loosened up the rules (while increasing the insurable deposit limit) to allow "investments" in more high risk ventures, most of which turned out to be frauds, or worse, money laundering operations for drug criminals. This includes Whitewater, Flowerwood, and Castle Grande.

"Despite shifting the S&L loss primarily onto the taxpayers (to reassure foreign investors that the taxpayers still made America a safe place to park their surplus cash) the government plunged further into debt.

"In the 12 years of the Reagan/Bush administrations, the United States went from being the world's largest creditor nation to the world's largest debtor.

"Many of those nations which had enjoyed huge trade surpluses started loaning that profit back to the United States with the stipulation that we work on our manufacturing, clean up our infrastructure, raise taxes, in short, clean up our act, so that investment in America makes sense!"

"However, we didn't quite do that.

There has been some shuffling around to try to conceal the real scope of the problem.

"Over the last several years, the Federal Government has been sending less tax money back to the states than it takes in taxes. This means that the states have to borrow MORE money to cover their obligations. The net result is that the debt is being transferred to the states, to conceal its true size."

Your Retirement

"Yet another stunt the government has pulled is to "borrow" from the various trust funds under its control. Some \$2 billion has vanished from the trust accounts of Native Americans (presently suing the Departments of the Interior and Treasury), and nearly $\frac{3}{4}$ of a TRILLION dollars has been removed from your Social Security retirement trust fund and spent in the last 8 years.

"If the government has to borrow your retirement money when things are supposed to be so good, under what conditions can it repay the money?"

"Or is that government IOU in your retirement account merely a promise to either tax you a second time or stiff you on the benefits you thought you were paying for?"

"In the last 8 years, during what are supposed to be record setting good times, the Federal government has nearly doubled its debt load. ... Our government is so deep in debt that it cannot get out.

Collateral:

"This brings us to the issue of collateral. We've borrowed so much money the lenders are getting nervous. Back during the Johnson administration Charles DeGaulle demanded the United States collateralise the loans owed to France in gold and started carting out the bullion from the treasury.

"This caused several other nations to demand the same and President Nixon had to slam the gold window closed or the treasury would have been emptied, since the United States was even then in debt for more money than the treasury could cover in gold.

"But Nixon had to collateralise that debt somehow, and he hit upon the plan of quietly setting aside huge tracts of American land with their mineral rights in reserve to cover the outstanding debts. But since the American people were already angered over the war in Vietnam, Nixon couldn't very well admit he was apportioning off chunks of the United States to the holders of foreign debt.

"So, Nixon invented the Environmental Protection Agency and passed draconian environmental laws which served to grab land with vast natural resources away from the owners and lock it away, and even more, prove to the holders of the foreign debt that US citizens were not drilling, mining, or otherwise developing those resources.

"From that day to this, as the government sinks deeper into debt, the government grabs more and more land, declares it a wilderness or "roadless area" or "heritage river" or "wetlands" or any one of over a dozen other such obfuscated labels, but in the end the result is the same.

"We The People may not use the land, in many cases are not even allowed to enter the land.

"This is not about conservation, it is about collateral. YOUR land is being stolen by the government and used to secure loans the government really had no business taking out in the first place. Given that the government [As a servant of Globalism] cannot get out of debt, and is collateralising more and more land to avoid foreclosure, the day is not long off when the people of the United States will one day wake up and discover they are no longer citizens, but tenants." EQ

Government easily admits to a \$3 trillion "publicly held" debt; grudgingly concede that it's "unfunded liability" brings that number to almost \$7 trillion, but the real hard truth is that total government debt, state and federal, is now over \$14 trillion dollars, or about \$50,000 for every soul inside the United States. Since 1960, the taxpayers have paid \$15 trillion in interest payments, while the principal continues to rise. Note: the above was before the huge waste of present war years.

So we can see why control of the economy, in private hands, is a harlot that so easily leads "Party System" M.Ps (who have no more financial know-how than most of us) and how important is the power to select election candidates.

Also, as we saw (US of A) tax dollars are now not enough to pay interest on money borrowed and all, from pensioner to newborn baby; will soon owe multiples of \$50,000 of rapidly growing debt.

This does not include personal debt or money owing by the business for which you work. Some argue about the technical working of this fraud but so long as we bow to confidence trickery, its power to deceive, corrupt and rob is only limited by its consequences.

What is the value of the U.S. dollar today, seventy years after the gold standard was disinherited: how much would your 24.75 grain dollar be worth with gold at \$500 per ounce? There are 480 grains to the ounce troy. That is over \$1.00 per grain for 24.75 grains so, in easy rounded figures, the cost of inflation caused by printing money without backing of value, means that your dollar only buys one part of twenty-five of the work put into it.

Over 70 years the other 24 parts was skimmed off by Globalism and a lot of that used to ensure your ignorance of important matters. Are you really worth so much?

But a problem with the gold standard is that, although good enough in a more honest world, the value of gold is now open to manipulation. So how can we have a universal, natural and agreed, value for money?

The Horse Power example

The power of a motor or prime mover is measured in "horse power". This was related to the work effort of an average sort of horse in a given time. Once that figure was agreed on it was not open to manipulation.

The true value of a dollar is a measure of work produced by an average worker in a given time; say one hour at the time of the gold standard! Had that value been set as the legal value backing each dollar, it wouldn't stop criminal governments wasting money; for honest government we have to grow up; become mature; be responsible and govern ourselves.

So, given today's technology and working as hard as once was, are you surprised that your dollar, without robbery, would be worth 25 times more? Given an honest philosophy we just could not imagine how different our world would be. Those huge office blocks, producing nothing of value replaced by useful structures. Everyone using their lives more rewardingly; the difference made by an honest philosophy is unimaginable.

Who cares, its only money. The present mess – just a shiver of the earthquake to

come; the world suffers because all that money we owe is available to elitists for our deception and enslavement. When will they pull the plug? Fun game 'eh'? Are you laughing!

I don't know all the answers; I do know that our potential is amazing. We now complain about: wages: living cost: prices; anything but the cause! The Federal Reserve System, with help of our ignorant politicians, robs us of so much more than the value of money – we live as zombies.

Find that hard to believe?

Well remember in Gold Standard days a workman could support a wife and family, now he can only support a small family with the aid of a working wife and often some handout from government for which he and his family share huge debt. Also remember there was a time we could afford to build roads and railways that we now cannot afford to maintain!

Not only that but many public assets and services are now owned or given in security for public debt in accord with criminal law introduced by YOUR criminal controlled government.

We are all set to be begging for light, food and water in the foreseeable future and the present financial upheaval just represents the bringing of a little of that debt into inflationary service. The moneylenders will foreclose when things are tough then money will become practically worthless and the banking system collapsed.

The 'Equities' markets.

"...This brings us to the "equities markets", most notably the stock market. Over the last several years a constant media harangue has assured us that the

soaring numbers of the stock market are the sole measure of how good our economy is. But close examination of those high-priced stocks reveals that most are heavily over-valued; their price the result of market forces rather than underlying worth (earnings ability). Amazon.com, as one example, has had a terrific run-up of its stock price, even though the company itself has yet to show a profit.

"The government has admitted to using covert means to prevent a market downturn; to keep the stock prices at an artificially high and overvalued level, in order to wave those impressive numbers about as "proof" that everything is okay so that the taxpayers go back to work and pay more taxes. But in order to keep those stock prices up above their actual worth, demand must be maintained to keep the prices high.

In other words, NEW investors must constantly be brought into the bottom of the pyramid to keep the prices of the stocks at the top from dropping. Hence the onslaught of commercials luring neophyte investors into the stock market via "online trading". "Like any Ponzi scheme, the stock market will collapse when no more new buyers can be dragged in at the bottom. ...

"In the end, there is no such thing as a free lunch. You cannot make money grow in value by shaking it back and forth from one bank to another. You cannot prosper a nation by doing each other's laundry, or filling out their government mandated and greatly obfuscated paperwork, or flinging stock certificates around which may have as little worth as Federal Reserve Notes.

"To make money, to show a profit, you must make products that somebody else wants to buy, and sadly, that is a capability the United States [And 'advanced' nations] has allowed to slip away in great measure. The "service economy" was political propaganda to make the public believe that the decline of our manufacturing ability was a good thing.

"Our nation is broke, bankrupt, and having sold much of its machinery and technology (or given it away to political donors), is unable to easily return to those endeavors which once made our nation great. Our infrastructure is in decay (the percentage of roads in the US with major damage doubled last year alone), our public schools unable to produce a workforce able to function in a high-tech manufacturing environment, and those managers and engineers with manufacturing experience have in great part been lured away to other nations". EQ [Emphasis Added.]

"Cui Bono" / "Who Benefits"?

**a) McFadden even suggested that the Federal Reserve deliberately triggered the great stock market crash of 1929, in order to eventually force the passage of the Emergency Banking Act of March 9, 1933, which suspended the gold standard.*
